Thank you for your email of 22 March 2018 requesting the following information:

"JSP 464 Vol 3 Pt 1 (V6.0) explains in detail the CAAS methodology and technical sources of information that make up the UK CAAS assessment. The JSP's para 0518 specifically details the arrangements/methodology for CAAS location assessment overseas. However, subsequent CAAS grading letters to occupants detail the outcome of the methodology but do not provide the objective criteria/weighting and 'technical sources' needed for personnel to replicate/validate CAAS location (i.e. levels of broadband access, level of deprivation) outcomes.

Having requested this information from DIO they have referred the matter back to the EJSU stating the location factor was calculated by the Centre for Housing Policy at the University of York using data gathered by EJSU and ICTs (local command group for Europe) and the Housing Colonels (JFC).

Therefore, for Ramstein Germany, I request full details of:

- How, and copies of, the relevant data gathered by the Centre for Housing Policy at the University of York and by EJSU and ICTs was used.
- The objective criteria/weighting and 'technical sources' used to derive the CAAS 'Location' factor assessment.

Happy to clarify request as required. It is disappointing that after several years the 'more transparent system' [1] demanded and provided to UK personnel seems to have simply not been reciprocated for many serving overseas. So in essence I require the information that would allow UK Service personnel at Ramstein to validate the CAAS assessment 'location'

Lastly, as Ramstein is a major wide-body aircraft military operational airfield with a number of UK SFA properties adjacent/within the near vicinity of the airfield. I would like confirmation of how the

Ramstein SFA relative noise thresholds were determined."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that some information, in scope of your request is held.

The information you have requested can be found enclosed at annex A and B. At annex A you will find a copy of the 'CAAS WG Overseas Location Decision Summary', this was a product of the data gathering. At annex B you will find a copy of the CAAS assessment of the location factor for Ramstein.

The information requested on how the Ramstein SFA relative noise thresholds were determined, is not held. This part of the process was dealt with by a Sub Contractor.

Under Section 16 of the Act (Advice and Assistance) it should be noted that the overseas location factor are due to be reviewed this year with any changes applied from 1 April 2019.

CO EJSU's view	This location is more challenging than first impressions. Of note is the lack of spousal employment, access to schools and language challenges. A balanced analysis of the facts above support the assessment this location is INTERMEDIATE . That said, I urge the board to consider making this location REMOTE as an incentive towards overseas service. Demonstrably showing the MOD understands the intangible challenges of serving overseas will encourage greater service with NATO.
