# JUDGMENT

### Employment Tribunals Rules of Procedure 2013 – Rule 21

#### First Claimant (Nicholls)

- 1. The Respondent has made an unauthorised deductions from the Claimant's wages and is ordered to pay him the net sum of £5,495.16.
- 2. The Claimant was dismissed in breach of contract in respect of notice and the Respondent is ordered to pay damages to him in the net sum of £4,176.34.
- 3. The Claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £5,334.00.
- 4. The Respondent has failed to pay the Claimant's holiday entitlement and is ordered to pay him the sum of £1,312.52.
- 5. The hearing listed on 9 and 10 May 2019 is cancelled.

#### Second Claimant (Duncan)

- 6. The Respondent has made an unauthorised deductions from the Claimant's wages and is ordered to pay him the gross sum of £1,760.00.
- 8. The Claimant was dismissed in breach of contract in respect of notice and the Respondent is ordered to pay damages to him in the net sum of £1,348.20.
- 9. The Claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £674.10.

#### Case No: 1404891/2018, 1404953/2018, 1404960/2018, 1404967/2018

- 10. The Respondent has failed to pay the Claimant's holiday entitlement and is ordered to pay him the sum of £560.00.
- 11. The hearing listed on 9 and 10 May 2019 is cancelled.

Third Claimant (Hodsoll)

- 12. The Respondent has made an unauthorised deductions from the Claimant's wages and is ordered to pay him the gross sum of £10,000.00.
- 13. The Claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £1,200.00.
- 14. The hearing listed on 9 and 10 May 2019 is cancelled

Fourth Claimant (Tait)

- 15. The Respondent has made an unauthorised deductions from the Claimant's wages and is ordered to pay him the gross sum of £4,382.80.
- 16. The Claimant was dismissed in breach of contract in respect of notice and the Respondent is ordered to pay damages to him in the net sum of £3,692.15.
- 17. The Claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £3,556.00.
- 18. The Respondent has failed to pay the Claimant's holiday entitlement and is ordered to pay him the sum of £1,768.00.
- 19. The hearing listed on 9 and 10 May 2019 is cancelled.
