- c) Who is responsible for ICT Purchasing in the organisation and what are their contact details?
- 3. Staff
- a) How many IT users do you have?
- b) How many locations/offices do you have?

- be provided with that information (subject to any exemptions under the Act which may apply).

The answers to your questions are that the Office of Manpower Economics (OME) does not hold the information you require. The OME is funded by the <u>Department for Business</u>, <u>Energy and Industrial Strategy</u> (BEIS), and they would be responsible for all Procurement and IT services provided to the Office.
