Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The start date for the above Order is 12 February 2019.

Consideration of the Order will take the form of a hearing.

The Hearing will be held at **County Hall, Northallerton, DL7 8AH** on **Tuesday 16 July 2019** at 10.00 a.m.

The effect of the Order, if confirmed without modifications, will be to divert the public bridleway described below and modify the District of Richmondshire (Outside the Yorkshire Dales National Park) Definitive Map and Statement accordingly.

Bridleway No. 20.55/6 will be diverted **from** a diagonal line across a field south-east of Mainsgill Farm, running east-south-east from Point A (grid reference 41527 50845) for approximately 29 metres to Point B at grid reference 41530 50843) then north east for approximately 124 metres to Point C (grid reference 41540 50850) **to** a new route starting at the aforementioned Point A running north around the outer perimeter of the same field for approximately 5 metres to Point D (grid reference 41527 50845) and then east-south-east for approximately 80 metres to Point E (GR 41534 50841), then north-north-east for approximately 107 metres to re-join the existing bridleway through Mainsgill Farm at the aforementioned Point C. There will also be a new permissive bridleway running to the west of Mainsgill Farm to avoid the farmyard.

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 12 weeks of the start date [by 7 May 2019]

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Hearing must ensure their statement of case¹ is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.

This Order is made by North Yorkshire County Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the bridleway described in Paragraph 1 of this Order it is expedient that the line of the way should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that The District of Richmondshire (Outside the Yorkshire Dales National Park) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Mr M Henshaw of Mainsgill Farm, Ravensworth has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the way into a fit condition for use by the public.

Richmondshire District Council and Ravensworth Parish Council have been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

- For the purposes of this Order the relevant date is 7 August 2015.
- 2. The public right of way over the land situated at Mainsgill Farm, Ravensworth and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up from the date of confirmation of this Order, and thereupon The District of Richmondshire (Outside the Yorkshire Dales National Park) Definitive Map shall be modified by deleting from it that public right of way.
- 3. There shall from the date of confirmation of this Order be a public bridleway over the land situated at Mainsgill Farm, Ravensworth described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order, and thereupon The District of Richmondshire (Outside the Yorkshire Dales National Park) Definitive Map shall be modified by adding that way to it.
- 3A. The District of Richmondshire (Outside the Yorkshire Dales National Park) Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.


