Dear [REDACTED],

Thank you for your e-mail of 26 August 2018 to the Ministry of Defence requesting the following information:

*"I understand that there is a Bi-lateral agreement between the UK/USA concerning Medical Services for retired service personnel with Service Related Injuries!  
Can you tell me what services are provided in the UK and whether their families are included.  
Are there any medical services included where no injuries exist?"*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that some of the information in scope of your request is held.

Please find attached a copy of the "Executive Summary of the Memorandum of Understanding (MOU) for the Treatment of Defence Business Services Vets UK (DBS Vets UK) War Pensioners and/or Armed Forces Compensation Scheme (AFCS) Members residing in the USA." This document provides a basis by which UK Veterans can receive treatment for conditions which are accepted as being caused by their Service in HM Armed Forces, just as they would receive via the National Health Service if they resided in the UK.

Treatment costs are initially paid by the US Vets Affairs and are reimbursed by the British Government via DBS Vets UK. The memorandum sets out the process for approval of treatment and funding, however, it is important to note that this memorandum is not a reciprocal agreement.
