The Public Passenger Vehicles Act 1981 (as amended) ("the Act")

<u>Decisions made in respect of the operator's licence held by New Adventure</u> Travel Ltd PG1079161

- 1. The operator has failed to operate a local service that it registered with the Traffic Commissioner, section 26(1)(a) of the Transport Act 1985.
- 2. The operator has operated a local bus service outside of the timings registered with the Traffic Commissioner, section 26(1)(b) of the Transport Act 1985.
- 3. Arrangements for maintaining vehicles used on local services have not been adequate, section 26(1)(c) of the Transport Act 1985.

- 4. Adverse findings are made under sections 17(3)(a); 17(3)(aa); and, 17(3)(c); and, 17(3)(e) of the 1981 Act.
- 5. I do not make an adverse finding under section 17(3)(e) of the 1981 Act.
- 6. The operator continues to satisfy the requirements relating to financial standing, stable establishment, professional competence and repute.
- 7. I give a formal warning to the operator for failures.
- 8. I approve the new operating centre in Builth Wells.
- 9. I grant an increase in discs to 150.
- 10. I impose a financial penalty under section 155 of the Transport Act 2000. It will be 150 pounds for each of the 117 discs authorised currently. This total of 17,550 pounds is payable to the Welsh Government within 28 days of receipt of the decision in writing.
- 11. Decisions made in respect of transport manager Eifion Daniel Clarke Repute is retained with a warning.
- 12. Decisions made in respect of transport manager Christelle Borchard Repute is retained with a warning.
- 13. Decisions made in respect of transport manager Kevyn Francis Jones Repute is retained with a warning.
- 14. Decisions made in respect of transport manager Wayne Cowling I accept Wayne Cowling as a transport manager.
