Your correspondence dated 20 November 2018 has been considered to be a request for information in accordance with the Freedom of Information Act 2000. You requested the following information:

To ask for the in-year spend totals for each of the programmes listed on p37 of the Defence Equipment Programme 2018-28.

Please see the response below.

Page 37 of the Defence Equipment Plan 2018-28 is the Project Performance Summary Table (PPST) which provides an overview of the delivery performance on the Department's largest equipment procurement projects, that have been approved for Demonstration and Manufacture phases. It reports against forecast costs agreed as part of the Main Gate business case or when we commit to manufacture of the equipment.

The total, verified and audited spend data for these projects in the current financial year, is not available as this is currently incomplete. The table below presents spend in 2017/18 on demonstration and manufacture phases of projects listed in the Equipment Plan 2018 PPST. Spend on demonstration and manufacture phases has been used so that it is comparable with the PPST data.
