Your correspondence dated 19 December 2018 has been considered to be a request for information in accordance with the Freedom of Information Act 2000 (FOIA). You requested the following information:

Under the Freedom of Information Act, I request:

- 1. The number of fruitless payments (payments for which liability ought not to have been incurred or whether the demand for the goods and services in questions could have been cancelled in time to avoid liability) in excess of £30,000 made by or paid for by your department in the financial year 2018-19 to date.
- 2. What each payment was for
- 3. The value of each payment
- 4. The reason why the payment was made
- 5. The reason why the payment was classified as fruitless
- 6. Whether any disciplinary action was taken as a result of the payment (if there was any disciplinary action, please specify what the action was).
