

Thank you for your letter of 5 November requesting the following information:

*"I have been asked to supply a detailed breakdown of the curriculum/syllabus taught and marks gained when I was at St Athan on my MT Technicians course studying for my City and Guilds Level 3 and NVQ level 3."* 

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held.

The breakdown of the modules that you would have undertaken on the Mechanical Transport Technician Further Training course can be found at annex A. However, Accreditation Flight do not hold a record of your examination results. Unfortunately, due to a change in training management information systems in 2012, all historical records for examination results prior to this date have been lost.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that the marks gained for your course may be held on your Record of Service. As these marks, if held, constitute your own personal data, you can request this via a Subject Access Request (SAR) under the Data Protection Act. If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact us in the first instance at the address above. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail <u>CIO-FOI-IR@mod.uk</u>). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the FOIA. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
