Thank you for your email of 4 March 2019 requesting the following information:

- "1) Could the department please provide information on whether there are any proposed or approved policy changes to PAPMIS and provide details of any proposed or approved changes and when these will be rolled out.
- 2) Could the department please provide information on
- a) If there is any accommodation specifically for lesbians serving within the Armed Forces.
- b) The number of reported female on female assaults for the year 2019 so far, 2018, 2017 and 2016.
- 3) The number of houses owned by the MoD which fall under what used to be categories III and IV of the 4 tier grading system.
- 4) Any anticipated costs of altering SLA and SFA to be suitable for injured personnel returned to unit."

Your email has been passed to the Defence People Secretariat within the Ministry of Defence (MOD) and I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOI Act).

In regard to Question 1, the Army Medical Employment Policy is routinely reviewed and updated. Updates to the policy often necessitate updates to the PAPMIS software application. Changes are currently being introduced. However, as these changes need to be programmed and tested by the software development team whose responsibilities range beyond PAPMIS, it is not possible to confirm exactly when each change will be completed.

In regard to Question 2a, Single Living Accommodation in the Armed Forces is allocated on the basis of rank and sex but not on sexual orientation.

In regard to Question 2b on reported cases of female on female assaults, please note that this information is not held centrally. Information for the Royal Navy is not held in the format requested. However, information held by the Army and the Royal Air Force is presented in the tables below.

In regard to Question 3, the 4 Tier Grading (4TG) system was replaced by the Combined Accommodation Assessment System (CAAS) in April 2016, and due to the differences in the way they are categorised, the Department is unable to provide a comparison between the two. However, we are able to provide the 4TG scores for the properties that are the responsibility of the Defence Infrastructure Organisation (DIO) as at end of March 2016 and the current CAAS band totals as of 13 March 2019, seen below:

In regard to Question 4, if a medical team decides that the SLA or SFA cannot meet the needs of the Service person, then the individual's Unit would arrange for the accommodation to be adapted. The Department is unable to provide anticipated costs of altering SLA and SFA suitable for injured personnel returned to their Unit. Each adaptation is unique to that individual, therefore these costs are not forecasted.
