Notes regarding the data:

- The report counts the postcodes of claimants/defendants (or petitioner/applicant versus respondent for family) at each hearing. Solicitor postcodes are excluded.
- Every effort is made to ensure that the figures presented are accurate and complete. However, please note that figures are derived from the administrative data systems utilised by the courts for case management and are subject to the inevitable limitations of manual recording and large administrative systems, such as late reporting.

- Figures reflect what is recorded on the administrative system, have not been crossreferenced with case files and are not subject to the same level of checks as official statistics.
- Figures are based upon the most recent available data and for that reason might differ slightly from any previously published information.

This government is investing over £1billion to reform and modernise the justice system – making it more convenient, easier to use, and providing better value for the taxpayer. Since April 2016 we have raised £115m from the sale of underused court buildings – over £34m more than forecast, and every penny of this will be reinvested as part of our modernisation plans.

As we increase the use of digital services, it makes sense to consider the wider role and need for court buildings and assess whether some are still necessary to provide effective access to justice. Wandsworth County Court is old and underused. It's utilisation rate was 36% between April and September 2017. We are currently consulting on our proposals and encourage interested parties to take part.
