Freedom of Information Act (FOIA) Request – 180320021

You asked for the following information from the Ministry of Justice (MoJ):

- 1. Chorley Magistrates' Court sat for a total of 1512 hours out of a possible 3810 in 2016/17. How does this workload compare with the previous 7 years?
- 2. Since 2010 services that were previously conducted at the Court have been removed; please can you provide a breakdown in the changing nature of the workload over the previous 7 years?
- 3. Failure to Attend figures.

Your request has been handled under the FOIA.

I can confirm that the MoJ holds some of the information that you have requested and I have provided it below. I should explain that our Magistrates' Courts case management and management information systems only hold complete data for the last 6 years. In response to each question:

Q1 and Q2. Chorley Magistrates' Court sat for a total of 1512 hours out of a possible 3810 in 2016/17. How does this workload compare with the previous 7 years? Please can you provide a breakdown in the changing nature of the workload over the previous 7 years?

- No area was specified and so the data covers Chorley Magistrates Court, County, Region and England and Wales for comparative purposes.
- Figures quoted are for each Criminal Case where a Non-Appearance Warrant was
 issued in the period specified, rather than a count of defendants. Hence, where a
 defendant has more than one case for which a Non-Appearance Warrant was issued,
 each case will count separately, and where more than one Non-Appearance Warrant
 was issued for the same case in the same reporting period, each issuance will be
 counted separately
