Nuffield Footpath No. 25 and Stoke Row Footpath No. 24 (part) Public Path Diversion and Definitive Map and Statement Modification Order 2015

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

### The **start date** for the above Order is **1 May 2019**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by diverting 230m of Nuffield Fp 25 and Stoke Row Fp 24 that runs from Howberry Lane (Nuffield Br No. 17) at OS Grid Ref SU 6887 8570 south-westwards across the garden of Howberrywood Farmhouse and then west-north-westwards across an arable field over the Nuffield and Stoke Row Parish boundary to SU 6865 8574 **to** a line running for 305m from Howberry Lane (Nuffield Br No. 17) at OS Grid Ref SU 6890 8567 south-westwards through a wood and over a field and over the Nuffield and Stoke Row Parish boundary at SU 68823 85617 to SU 68820 85615 and then north-westwards along a field margin to re-join the existing Stoke Row Fp 24 SU 6865 8574 as shown on the Order map.

### Timetable for sending in statements of case and comments

### Within 2 weeks of the start date [by 15 May 2019]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will

send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

## Within 8 weeks of the start date [by 26 June 2019]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

## Within 14 weeks of the start date [by 7 August 2019]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the timetable</u> to ensure that statements of case and comments are received on time. Late documents will be returned.

## PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981

### The Oxfordshire County Council Nuffield Footpath No.25 and Stoke Row Footpath No. 24 (part) Public Path Diversion and Definitive Map and Statement Modification Order 2015

This Order is made by The Oxfordshire County Council ('the authority') under section 119 of the Highways Act 1980 because it appears to the authority that in the interests of the owner and occupiers of the land crossed by the footpath described in Article 1 of this Order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Oxfordshire County Council Definitive Map and Statement of Public Rights of Way for Oxfordshire require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Mrs RK Grimond has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the way into a fit condition for use by the public.

South Oxfordshire District Council has been consulted as required by Section 120(2) of the Highways Act 1980.

#### BY THIS ORDER:

- 1. The public right of way over the land situated at Nuffield and Stoke Row and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be extinguished from the date of confirmation of this Order and thereupon the Oxfordshire County Council Definitive Map of Public Rights of Way for Oxfordshire shall be modified by deleting from it that public right of way, and the Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.
- 2. There shall be from the date of confirmation a public footpath over the land situated at Nuffield and Stoke Row (as described in Part 2 of the Schedule) and shown by a bold broken line on the map attached to this Order, and thereupon the Oxfordshire County Council Definitive Map of Public Rights of Way for Oxfordshire shall be modified by adding that right of way to it, and the Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.

3. Notwithstanding this Order, statutory undertakers with apparatus over/under the land described in Article 1 above shall have the following rights over the land referred to, namely: they shall continue to have the same rights in respect of such apparatus as they had immediately before the extinguishment took place.

#### DESCRIPTION OF SITE OF EXISTING WAYS

#### Nuffield Fp 25:

The entire width of Nuffield Fp No 25 that runs from Howberry Lane (Nuffield Br No. 17) east of Howberrywood Farmhouse at OS Grid Ref SU 6887 8570 (Point A on the Order plan) south-westwards for approximately 27m to SU 6885 8568 (Point B), then west-north-westwards for approximately 196m to the Stoke Row Parish boundary at SU 6866 8574 (Point C).

#### Stoke Row Fp 24:

The entire width of Stoke Row Fp No 24 that runs westwards and then southwestwards from the Nuffield Parish boundary at SU 6866 8574 (Point C on the Order plan) for a distance of approximately 7m to SU 6865 8574 (Point D).

#### PART 2

#### DESCRIPTION OF SITE OF NEW WAYS

#### Nuffield Fp 25:

A new footpath with a width of 1.5m that runs from Howberry Lane (Nuffield Br No. 17) south-east of Howberrywood Farmhouse at OS Grid Ref SU 6890 8567 (Point E on the Order plan) south-westwards for approximately 95m to the Stoke Row Parish boundary at SU 68823 85617 (Point F).

#### Stoke Row Fp 24:

A new footpath with a width of 3m that runs from the Stoke Row Parish boundary at SU 68823 85617 (Point F) south-westwards for approximately 4m to OS Grid Ref SU 68820 85615 (Point G), then north-westwards for 206m to SU 6865 8574 (Point D).


