FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: ALLOCATION OF EXPENDITURE

I refer to your e-mail dated 12 October 2018, which was acknowledged on 15 October 2018.

We are treating your e-mail as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your e-mail you requested the following information:

“[REDACTED] wanted to know how much expenditure had been allocated for the financial year 2019/20 to the purchase of (a) Riot Batons; (b) Personal Protective Equipment for use in Riot Control operations; (c) Riot Shields; and (d) Non-Porous Bags used for the storage and transportation of corpses?”

[REDACTED] would be grateful if you could provide this information for your force, and set out:

1. How this compares to the expenditure allocated for the purchase of the same items by your force in Financial Years (a) 2018/19; (b) 2017/18; (c) 2016/17; and (d) 2015/16?; and
2. What additional financial support your force has received from the Home Office to cope with any increase in these costs?”

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

How much expenditure had been allocated for the financial year 2019/20 to the purchase of (a) Riot Batons; (b) Personal Protective Equipment for use in Riot Control operations; (c) Riot Shields; and (d) Non-Porous Bags used for the storage and transportation of corpses?
