We do not hold the number of requests for the remaining data subject's rights. When recording the numbers of GDPR requests received we do not distinguish between the type of request except those which specifically relate to subject access requests.

- All subject access requests were answered within the one-month deadline.

As explained above, we do not distinguish between the type of request or whether the request was refused. To be of assistance, the Registrar of Companies has a legal obligation to make information on companies available to the public under the requirements of the Companies Act 2006, which includes information about the officers of those companies. As such, the registrar may rely on the exemption at paragraph 5 of Schedule 2 Part 1 and it is unlikely that she will need to comply with a data subjects request to exercise their rights under GDPR.
