**The unemployment data included in this update was only available for 2017 ward boundaries which do not consistently match the 2018 ward boundaries employed in this update. The result is that data for 451 ward areas are missing.*

The following indicators have been removed from Local Health in the June 2019 update to create capacity to allow new indicators to be added, and to help ensure the tool remains relevant to meeting user needs. Feedback on which indicators to remove was sought through the 2018 Local Health user survey.

The indicator of deaths from coronary heart disease, under 75 years, has also been removed as data for 2013 to 2017 showed that in a substantial proportion of areas, results were based on very small numbers. This indicator is therefore no longer considered statistically meaningful for small areas.
