## **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information on Egg Codes which we received on 23 May 2018. Your request has been part handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"I'd like to find a list of all the producer codes used on eggs ("egg codes"). From reading your website, it looks like these are "hen laying establishments" registered via form EMR02b?

Please find attached the request list as Appendix 1.

Is this list currently made public anywhere? I can see some sites (eg <u>http://www.foodmiles.com/egg-miles.cfm</u>) which do a reverse lookup using the code, but I can't find the raw list anywhere."

The list has not been made public to date. However all Freedom of Information requests are subject to Publication on GOV.UK.
