# PROVISION OF REQUESTED INFORMATION

Thank you for your request for information commercial dog transporter authorisations which we received on 06 June 2018. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

'I was hoping someone could tell me the following:

1. How many current type 1 and type 2 transporter authorisations are in place for commercial dog-related businesses (importers/charities/breeders/sellers)

There are 5113 currently valid Type 1 and 2 Transporter Authorisations where the Transporter has been granted authorisation to transport 'Other' species. Please note that this also includes transporters who are authorised to transport 'All' species.

2. Are there any current transporter authorisations for dog sitting/dog walking businesses? If so how many?

The Animal and Plant Health Agency (APHA) do not record the purpose of an authorisation. Therefore APHA are unable to advise on whether any of the 5113 are for commercial dog-related businesses.

3. Have any specific conditions ever been imposed on an authorisation in regards to the transport of dogs/puppies?

In order to check which Transporter Authorisations contain conditions which restrict the transporter to transport animals APHA would have to locate all 5113 copies of authorisations and check each Transporter Authorisation individually. Each Transporter Authorisation is a bespoke document containing a variety of conditions placed upon the authorisation. All Transporter Authorisations with a start date prior to April 2014 were stored as paper copies, these Transporter Authorisations have been destroyed when the

The Animal and Plant Health Agency is an Executive Agency of the Department for Environment, Food and Rural Affairs working to safeguard animal and plant health for the benefit of people, the environment and the economy.

APHA Centre for International Trade – Carlisle office flooded in December 2015. In light of these circumstances we are unable to supply this information and following guidance from the Information Commissioners Office (ICO) a Section 12 exemption has been applied, details of which can be located following question 5.

4. Does APHA inspect vehicles transporting dogs/puppies at ports or control posts?

APHA conduct mid-journey compliance checks on vehicles at ports where APHA have a presence. There are no requirements under Council Regulation (EC) No 1/2005 on the protection of animals during transport for vehicles transporting canines to stay at livestock control posts.

Not every vehicle transporting animals is checked, the checks are either random or intelligence based.

5. Have any non-conformities been found with vehicles transporting dogs/puppies? If so what have they been/how many?'

In the last 3 years there have been 578 checks on vehicles transporting dogs, and 371 of these have shown non-compliances.

In order to conclude whether any recorded non-compliance involves the vehicle rather than a documentation or welfare issue, each statutory notice would have to be located and analysed. Following advice laid down by the Information Commissioners Office (ICO) a Section 12 exemption has been applied,

## Section 12

Questions 3 of your request has been withheld under section 12(1).of the Freedom of Information Act 2000 (FOIA)

Section 12(1) of the FOIA allows us to refuse a request for information if we estimate that the cost of complying with the request would exceed the appropriate limit, which currently stands at £600, and equates to 24 hours of staff time.

This is in excess of the 24 hour limit set out in section 12(1), and therefore the information has been withheld.
