## PROVISION OF REQUESTED INFORMATION

Thank you for your request for information on the number of pet passports issued which we received on 11 June 2018. Your request has been handled under the Freedom of Information Act 2000 (FOI)

The information you requested and our response is detailed below:

'Therefore, my request is for you to share the data on the number of pet passports issued in 2016 and again in 2017, please'

Number of blank pet passports issued by APHA to veterinary practices in 2016 is 95,449.

Number of blank pet passports issued by APHA to veterinary practices in 2017 is 91,661.

The Animal and Plant Health Agency (APHA) issue blank pet passports to approved Official Veterinarian (OV) practices who then issue these for cats, dogs and ferrets to move under the Pet Travel Scheme. We do not record the number of pet passports issued by OV practices to individual animals.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context.
