Thank you for your email of 4 April 2019 requesting the following information, which revised the scope of your original request (as amended below) to cover Germany rather than all sites in the UK and abroad:

"1.

- a. A list of all Aqueous Film Forming Foam products used on British military sites since 2008, in Germany.
- b. Known location of use of each product
- c. Known year(s) of use of the product
- d. Known content of perfluorinated alkylated substances (PFAS), e.g. perfluorooctanoic acid (PFOA) or perfluorooctanesulfonic acid (PFOS), of the product.
- 2.
- a. A list of all British military sites (in Germany) where there is known contamination with perfluorinated alkylated substances (PFAS), e.g. perfluorooctanoic acid (PFOA) or perfluorooctanesulfonic acid (PFOS)
- b. All details of any testing or sampling for contamination by the substances listed in 2.a., including the time and date of the taking of the sampling and exact location within the site, if available."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held.

The information you have requested can be found below.

## Part 1

The following table provides the information requested under Part 1 of your request by product category:

The current Aqueous Film Forming Foam that has been in service for the last four to five years in fire extinguishers does not contain PFAS and at the point of introduction, none of the ingredients were on the Organisation for Economic Co-operation and Development (OECD) banned chemicals list. We (and our commodities main contractor) do not hold information on the earlier fire extinguisher product in respect of its content.

Bielefeld, Gütersloh, Paderborn and Sennelager Barracks are still open/active in Germany; the following sites were open in 2008, but were handed back during 2014 to 2016: Hameln; Harewood Barracks, Hammersmith Barracks and Wentworth Barracks at Herford; Fallingbostel; Hohne; Alanbrooke Barracks at Paderborn; Tower Barracks at Dülmen; Princess Royal Barracks at Gütersloh; Kiel Training Centre.

## Part 2

There are no known sites in Germany with contamination from PFAS and no records of sampling or testing for these contaminants has been identified.
