BYE-LAWS

Made by His Majesty's Principal Secretary of State for the War Department, under the provisions of the Military Lands Acts, 1892 to 1903, for regulating the use of certain land at Lulworth in the occupation of the War Department specified in the Schedule hereto, for the purposes to which it is appropriated.

MILITARY LANDS.

BYE-LAWS

Made by His Majesty's Principal Secretary of State for the War Department under the Provisions of the Military Lands Acts, 1892 to 1903, for regulating the use of certain land at Lulworth in the occupation of the War Department specified in the Schedule hereto, for the purposes to which it is appropriated.

OFFENCES.

1. NO costermonger, hawker, pedlar, huckster, marine store dealer, dealer in rags, bones or bottles, or other dealer, or book-maker, or racing or betting tout, or vendor of newspapers or any kind of literature, or photographer, or person engaged in any similar traffic or occupation to any of those specified, unless in possession of a Pass issued under the authority of the Commandant, Royal Tank Corps Centre, shall intrude or enter or be upon the said lands, for the purpose of selling, buying or trafficking, or otherwise carrying on his or her or any like business or calling.
2. NO person shall enter or be upon the said lands for the purpose of idling, loitering, or behaving in an indecent or disorderly manner, or for the purpose of gaming, betting, gambling or wagering.
3. NO person shall enter or be upon the said lands for the purpose of carrying or applying for permission to carry the kit bags, etcetera, of Soldiers or other persons, or of obtaining any other kind of casual employment.
4. NO person shall enter or be upon the said lands for the purpose of removing cartridge cases, lead or any other kind of metal or other material from the Butts, unless duly authorised and in possession of a Pass issued under the authority of the Commandant, Royal Tank Corps Centre.
5. NO person shall enter or be upon the said lands after having been warned off by an Officer or by any person acting under the authority of an Officer.

6. NO person, unless in possession of a Pass issued under the authority of the Commandant, Royal Tank Corps Centre, shall camp or bivouac or sleep out on any of the said lands.

7. NO person, without the authority of an Officer, shall deposit broken glass or other rubbish upon the said lands.

8. NO night walker or common prostitute shall locate herself in, or trespass on, or resort to the said lands for the purpose of prostitution.

9. NO person, without the authority of the Commanding Royal Engineer of the Area, shall cut grass or growing crops, or cut and remove turf, or use the said lands for the purpose of grazing any horse, cow, sheep or other animal.

10. NO person, without the authority of the Commanding Royal Engineer of the Area shall cut or deface any growing trees, or remove any timber or trees from the said land.

11. NO person shall enter or be upon the said lands for the purpose of pursuing game or other animals, unless in possession of a Permit issued under the Authority of the Commandant, Royal Tank Corps Centre.

12. NO person, without the authority of an Officer shall light a fire on the said lands for any purpose whatever, nor shall any person by throwing down lighted or live matches or in any other way do anything causing or tending to cause a fire to break out on the said lands.

13. NO person shall ride a horse or bicycle, or drive any vehicle upon any footpath by the side of any War Department road or land, maintained by the War Department, and situate on the said lands.

14. NO driver of any motor car, motor cycle or other self propelled vehicle, shall drive at a speed exceeding twelve miles per hour upon any road, or part of a road, within the said lands, maintained by the War Department, on which notices, regulating the speed of such vehicles have been posted.

15. NO driver of a hackney carriage, taxi-cab or other vehicle shall enter or be upon the said lands for the purpose of plying for hire, without a Pass issued under the Authority of the Commandant, Royal Tank Corps Centre.

16. NO motor car, motor cycle, cycle, or other vehicle shall be driven over the said lands, or roads situated thereon, without a light between the hours of one hour after sunset and one hour before sunrise. The provisions of this Bye-law are in addition to and not in derogation of any existing Statute, local or other Bye-laws or regulations which may now or hereafter be in force.

17. **NO person shall remove or tamper with any red Flags, Targets, Notice Boards, Range Telephone or other**

equipment and apparatus or any other stores or articles on the said lands, nor shall any person remove or tamper with any shell or other projectile or part of a shell or other projectile found within the said lands.

RIGHTS OF WAY.

18. NOTHING in these Bye-laws shall interfere with any public right-of-way, but subject as aforesaid the expression "lands" shall include all roads on such lands.

OFFICERS AUTHORISED.

19. ANY person doing anything prohibited by or otherwise contravening any of the preceding Bye-laws numbers 1 to 17 shall be deemed to commit an offence against the Bye-law so contravened. The persons hereby authorised to remove or take into custody without warrant any person committing an offence against any of the preceding Bye-laws numbers 1 to 17 or to remove any vehicle, animal or thing found on the said lands in contravention of these Bye-laws are :—

- (1) The General Officer Commanding-in-Chief, Southern Command ;
- (2) The Officer in Charge of the said lands ;
- (3) Any Officer, Warrant Officer, Non-Commissioned Officer, or any Military Policeman for the time being under the Command of the said General Officer Commanding-in-Chief or the said Officer in Charge ;
- (4) Any person authorised in writing under the hand of the said General Officer Commanding-in-Chief or the said Officer in Charge ;
- (5) Any Constable.

DATE OF OPERATION OF BYE-LAWS.

20. THESE Bye-laws shall come into force at the date hereof, and shall remain in force until the termination or expiry of the lease of lands at Lulworth granted by Mr. Humphrey Joseph Weld (by his Committee) to His Majesty's Principal Secretary of State for the War Department, dated the thirteenth day of October, one thousand nine-hundred and twenty-seven. The aforesaid lease will terminate on the thirty-first day of August, One thousand nine hundred and thirty-four, but may be terminated by the Lessor or the said Secretary of State either on the thirty-first day of August, One thousand nine hundred and thirty-three, or the thirty-first day of August, One thousand nine hundred and thirty-two.

SCHEDULE.

LANDS AFFECTED.

THE lands to which the foregoing Bye-laws apply are situated to the South-West of East Lulworth and to the East of West Lulworth, lying between High Water Mark (between Warbarrow Bay and Lulworth Cove) and the East-West Lulworth Road, and are bounded as follows:—

On the North.—By the South side of the East-West Lulworth Road, from a point by Burngate Farm to a point at the North-West corner of Broom's Plantation.

On the East.—By the Western edge of Broom's Plantation to Old Marl Plantation, round the South-West corner of Old Marl Plantation, and thence southwards by the Eastern side of fields Nos. 223, 238, and 239, past Sea Vale Farm, to high Water Mark at Arish Mell.

On the South.—By the line of High water from Arish Mell to a point East of Lulworth Cove by Potter's Hole.

On the West.—By a line skirting Bindon Abbey and running Northwards to a footpath from West Lulworth, thence in an Easterly direction, passing South of West Lulworth Reservoir for six hundred yards and thence Northwards following the Parliamentary County Divisional Boundary to the junction of this boundary and the East-West Lulworth Road, West of St. Andrew's Farm and thence along the East side of the said Road to the starting point thereon by Burngate Farm.

NOTICES.

PENALTY FOR OFFENCES.

1. By Section 17 (2) of the Military Lands Act, 1892, it is provided that:—

If any person commits an offence against any Bye-law under this Act, he shall be liable, on conviction before a Court of Summary Jurisdiction, to a fine not exceeding FIVE POUNDS, and may be removed by any Constable or Officer authorised in manner provided by the Bye-law from the area to which the Bye-law applies, and taken into custody without Warrant, and brought before a Court of Summary Jurisdiction to be dealt with according to law, and any vehicle, animal or thing found in the area in contravention of any Bye-law, may be removed by any Constable or such Officer as aforesaid, and on due proof of such contravention, be declared by a Court of Summary Jurisdiction to be forfeited to His Majesty.

DANGER FROM UNEXPLODED SHELL.

Particular attention is drawn to Bye-Law No. 17, and owing to the danger from Unexploded shell or other projectiles on the said lands, the public are warned to keep to the footpaths over the said lands and not to touch any shell or portions thereof.

INSPECTION OF PLAN SHOWING LANDS AFFECTED.

3. The Lands described in the Schedule to which these Bye-laws apply are shown on a plan which can be inspected at the Headquarters, Royal Tank Corps Centre, Bovington Camp.

WHERE BYE-LAWS CAN BE OBTAINED.
