Thank you for your email of 23 January 2019 requesting the following information:

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that some information in scope of your request is held.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that the MOD does not hold the exact meeting places for the hunts as requested, any bid from a hunt will only include the dates and the areas of the training area they wish to cover.
