# School Applications and Offers Local Authority Level Data

## Underlying data time series metadata specification

### Description

This document describes the data contained in the 2019 school applications and offers underlying data file. The file contains national, regional and local authority data for both primary and secondary level applications and offers. The information contained in the underlying data is based upon the data returned by local authorities.

This year, for the first time, this document includes the underlying data both for this year, 2019, and also for all years since 2014, to provide an easily accessible time series. In the near future this dataset will be further expanded to include key percentages.

### Overview

The information collected in the file relates to the school applications and offers made each year on the respective national offer days, 1 March for secondary level and 16 April for primary level (in both cases or the next working day).

A full description of the methods used in the collection of this data can be found in the main text of the statistical release and the separate methodology document.

### File format and conventions

#### Format

2019Release\_Apps & Offers\_TimeSeries\_UD.csv – rows in this file relate to individual local authorities or regions.

#### Rounding

Suppression and rounding at regional level was applied in 2014 only: from 2015 onwards no suppression or rounding has been applied.

#### Coverage

The data includes returns from 151 local authorities. The Isles of Scilly has been excluded as it has one school where the normal point of entry for all children is at age 3 and pupils continue until aged 16.
