The information you requested and our response is detailed below:

"thank you for the information provided. I should have clarified my request with regards to Macedonia. It is the number of dogs entering from Macedonia with Macedonia as country of origin as I believe they would enter through Bulgarian BIP and not Croatian. Please provide for 2014-2108."

The number of dogs from Macedonia including dogs which entered the EU through a BIP in Bulgaria with a destination of the UK is as follows:
