## PROVISION OF REQUESTED INFORMATION

Thank you for your request for information on live animal exports which we received on 10 August 2018. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

'I am requesting under this FOI. The loading and inspection reports together with the Ramsgate Portal APHA inspection reports including time of first sheep loading, on the following three listed Transporters.

In addition I am requesting the number of persons registered under the APHA inspection as a licenced driver or licenced attendant for each Transporter. Please specify if two on any transporter whether they are both registered as licenced Drivers, for this livestock category of HGV.

#### **Section 40**

Some of the information contained within the requested documents has been withheld under section 40(2) of the FOIA as the information constitutes personal data relating to a third party. The FOIA provides that personal data relating to third parties is exempt information. The release of third party information, if disclosed, would also breach Article 5(f) of the General Data Protection Regulations (GDPR) - principles relating to processing of personal data.

APHA consider that disclosure of this information is likely to breach section 40(2) of the FOIA and Article 5(f) of the GDPR, which relates to appropriate security of personal data, including protection against unauthorized or unlawful processing. Therefore, we have concluded that this information is withheld.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
