General Comments

Although the ITAC stated that the lambs were going to be 7 months old MALES, the Schedule of identification of animals describe them as "Male + Female mixed - Cross Breeds, Texel X, Charolais X - 3 months old". The lambs were small; weighting around 25 kg and the stocking density was closely monitored during the loading to ensure that the welfare was not compromised.
