

## **Corrections to the Learners and Apprentices Survey report**

## **Summary**

The published report for the Learners and Apprentices Survey 2018 has been updated and republished to rectify minor errors and inconsistencies in two sets of figures. The first relate to the proportion of FE learners and apprentices who were claiming out-of-work benefits prior to starting their learning. The second relate to the proportion of FE learners and apprentices who had never worked prior to completing their learning and moved into work.

The corrections slightly reduce the proportion of FE learners and apprentices who were claiming out-of-work benefits prior to starting their learning and slightly increase the proportion of FE learners and apprentices who had never worked prior to their learning and moved into work. The effect of these changes are small and do not change the narrative of the report.

## **Description of error and impact**

Post-publication, a small number of inconsistencies were identified within the published report. It was decided to republish the report to correct this.

There were minor errors in analysis of FE learners and apprentices who had claimed outof-work benefits prior to their learning. The figures in the report have been updated to be defined consistently.

Analysis of FE learners and apprentices who had never worked prior to their learning and moved into work had been inconsistent in including or excluding those who were self-employed, which was a small proportion of the overall sample. These figures have been updated to include both employed and self-employed for FE learners and apprentices.
