- I (print name), being an Official Veterinarian of the United Kingdom, certify, with respect to the donor dog and canine semen identified above, the following:
- a) I am satisfied the donor dog has been continuously resident in an Australian approved country and was not under any quarantine restriction during and between the first and last semen collection;
- b) The donor dog was examined by a an Official Veterinarian of the United Kingdom on the day(s) of semen collection and again 30 to 45 days after the date of the

last semen collection on (date), and was found to be healthy and free from evidence of infectious or contagious diseases (including venereally transmitted diseases);

- c) The donor dog:
 - i) has tested negative for **Brucella canis** using a rapid slide agglutination test (RSAT), a tube agglutination test (TAT) or an indirect fluorescent antibody test (IFAT) on a blood sample collected 30 to 45 days after the last semen collection; **AND**

ii) has tested negative for Leishmania infantum using either an indirect fluorescent antibody test (IFAT) or an enzyme linked immunosorbent assay (ELISA) on a blood sample collected 30 to 45 days after the last semen collection; AND

iii) *has EITHER tested negative (less than 50% agglutination) at a serum dilution of 1:100 for Leptospira interrogans serovar Canicola using a microscopic agglutination test (MAT) on a blood sample collected 30 to 45 days after the last semen collection;

iv) *OR has been fully vaccinated against Leptospira interrogans serovar Canicola at least 14 days before the first semen collection and the vaccination was current at the time of the last semen collection;

- d) All the laboratory testing was conducted in an Australia approved country and in a UK Government laboratory or a laboratory recognised by the competent authority of the United Kingdom. Blood samples for laboratory testing were collected by an Official Veterinarian of the United Kingdom;
- e) An Official Veterinarian of the United Kingdom collected or was present and directly supervised the collection of the semen identified above from the aforementioned donor;
- f) At the time of semen collection, each semen straw/cryovial was permanently marked with the microchip number of the donor animal, the species and breed of the donor animal and the date of semen collection;
- g) (The semen was stored under the supervision of an Official Veterinarian of the United Kingdom and stored as follows:
 - i) *EITHER in a new shipping container;
 - ii) *OR in a shipping container that, prior to loading, was emptied and inspected and any loose straws/cryovials removed. The shipping container, including all surfaces contacting the straws/cryovials was disinfected on

- iii) AND only new liquid nitrogen has been added to the shipping container;
- h) The transport container was sealed by or under the direct supervision of an Official Veterinarian of the United Kingdom, using tamper-evident numbered seal;
