Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. Following an earlier exchange of written representations, the Inspector appointed to determine the Order issued a letter in which she proposed to make modifications to the Order as drafted. Following advertisement of those proposals, objections/ representations have been received.

The start date for the above Order is 11 June 2019.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case which contain evidence in respect of the Inspector's proposed modifications only.

The effect of the Order, if confirmed without modification will be to divert the full width of a section of Bugthorpe Footpath No. 1 commencing at Grid Reference SE 7625 5834 leading north-north-westerly for some 400 metres to Grid Reference SE 7615 5872 to a line some 604 metres in length commencing at Grid Reference SE 7625 5834 and leading westerly for some 102 metres then north-north-westerly for some 390 metres then east-north-easterly for some 112 metres to Grid Reference SE 7615 5872, as shown on the Order Map.

The effect of the proposed modifications would be to provide for the following modifications:-

(i) Amend the Schedule PART 2 to describe the width of the new path or way as a "3 metres with a centre line of 3 metres from the centre of the hedge"; and

(ii) Amend the Schedule PART 3 MODIFICATION OF DEFINITIVE STATEMENT, VARIATION OF PARTICULARS OF PATH OR WAY, ADDITIONS, column five (width) to read "*3.0m with a centre line of 3.0m from the centre of the hedge".

Everyone who has made an objection or representation following the proposed modification(s), the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the above date, the Secretary of State will send copies of the comments received to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the timetable</u> to ensure that statements of case and comments are received on time.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Humberside County Council Borough of East Yorkshire Definitive Map and Statement of Public Rights of Way require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, a highway shown or required to be shown in the map and statement has been authorised (by this Order) to be diverted.

Bugthorpe and Kirby Understale Parish Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Bugthorpe in the East Riding of Yorkshire and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after seven (7) days from the date of confirmation of this Order and thereupon The Humberside County Council Borough of East Yorkshire Definitive Map shall be modified by deleting from it that public right of way.

2. There shall at the end of seven (7) days from the date of confirmation of this Order be a public footpath over the land situate at Bugthorpe described in Part 2 of the Schedule and shown by a bold broken line on the Map contained in this Order and thereupon The Humberside County Council Borough of East Yorkshire Definitive Map shall be modified by adding that way to it.

- 3. The Humberside County Council Borough of East Yorkshire Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.
- 4. For the purposes of this Order the relevant date is the date upon which the Order comes into effect.


