You asked for the following information from the Ministry of Justice (MoJ):

In each of the individual years: 2014, 2015, 2016, 2017 and 2018.

 How many cases were dealt with by courts across England and Wales, where the defendant was charged with breaching the Prevention of Damage by Pests Act 1949.
For 2018 only, what was the outcome of cases dealt with by courts across England and Wales, where the defendant was charged with breaching the Prevention of Damage by Pests Act 1949.

3) For 2018 only, please provide a breakdown of the number of cases dealt with by courts in England and Wales, where the defendant was charged with breaching the Prevention of Damage by Pests Act 1949, by geographical court location. I.e. Birmingham Magistrates Court, Leeds Magistrates Court, etc.

Your request has been handled under the FOIA.

It has been passed to me because I have responsibility for answering requests relating to data in Her Majesty's Courts and Tribunals Service (HMCTS). HMCTS is an executive agency of the MoJ and is responsible for the administration of the magistrates' courts, the Crown Court, the County Court, the Family Court, the High Court, Court of Appeal and tribunals in England and Wales and non-devolved tribunals in Scotland and Northern Ireland.

I can confirm that the MoJ holds the information that you have requested and I have provided it below:

- a) Data are taken from a live management information system and can change over time.
- b) Data are management information and are not subject to the same level of checks as official statistics.
- c) The data provided is the most recent available and for that reason might differ slightly from any previously published information.
- d) The data supplied for Question one shows the number of Criminal Cases containing one or more offences under Section 3 (Occupier of land fail to notify Local Authority of rats/mice living on/resorting to in substantial numbers) and Section 5 (Fail to take required steps to destroy rats/mice on land after service of a Local Authority notice) of the Prevention of Damage by Pests Act 1949.
- e) As a case can have more than one offence and as such more than one outcome, the data supplied for Question two shows the number of Convictions and Non-Convictions for offences under Section 3 and Section 5 of the Prevention of Damage by Pests Act 1949.
- f) The data supplied for Question three shows a breakdown of the Magistrates' Courts who dealt with the Cases containing one or more offences under Section 3 and Section 5 of the Prevention of Damage by Pests Act 1949.
- g) The data provided has been extracted specifically to answer this question and has not been cross referenced with case files.
