"Is there a way of obtaining your bTB map data please, ideally with 8 or 10 digit OS Grid References in perhaps a .csv format?

This information is I know freely available with your ibTB mapping tool and accurate grid references found by comparing your map with an application which shows OS Grid references. It would, however, be helpful if this data were to be available in the abovementioned format.

I am not asking for any other information on breakdowns apart from that which is available with the ibTB mapping tool."

Please be advised that it includes the tb2, tb10 dates, and the Easting and Northing, from which the 10 digit OS Map references can be created if required.
