Thank you for your email of 24 May in which you requested the following information:

the number of troops forced to resign their positions from the Army as a result of criminal convictions from January 2016 to date [24 May 2019].

I would like to know the service from which they were dismissed and a brief summary of the reasoning.

For example:

January 2016 - Army private - sexual assault conviction.

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000. A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that information in scope of your request is held and has been provided below. However, some of the information falls entirely within the scope of the absolute exemptions provided for at sections 40 (Personal Data) and 21 (information accessible by other means), and has been withheld. Section 40 and section 21 are absolute exemptions and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

Information on the number of dismissals from the Army resulting from sentencing at Court Martial has been withheld under section 21 (information accessible by other means) please see below for further advice.

Information on the numbers and ranks of Army personnel who were awarded an AGAI 67 Major Administrative Action Sanction of 'Termination of Service' between 1 January 2016 and 24 May 2019 inclusive, as a result of being convicted at Civil Court are shown in the table below. Further information has been withheld under S40 (Personal information).

Please note that these figures are single service estimates and are not official statistics produced by Defence Statistics. Figures have been rounded to 10 to limit disclosure and ensure confidentiality. Totals have been rounded separately and so may not appear to be the sum of their parts. "-" denotes zero or rounded to zero.
