Thank you for your email of 15 May 2019 requesting the following information:

"Can you confirm the companies who are contracted by the MoD to provide meals to British armed forces personnel domestically and to those deployed on overseas operations? And can you provide a list of the beef producers used by these companies for which beef products are provided to armed forces personnel?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that some information, in scope of your request is held.

The information you have requested can be found below:

Catering Services are provided by Aramark Defence Services, Compass (operating as ESS) and Sodexo in the UK. Sodexo also provides catering services in Europe. Overseas Supply Services Limited (a company operated by Kellogg Brown Root) provides catering services in Afghanistan, Iraq, Oman, Bahrain and the UAE.

For personnel on active deployment food is provided through two companies contracted to the Deployable Food Programme, Vestey Foods in the UK and for those deployed overseas, Ecolog International. Vestey Foods in the UK and Ecolog International overseas:

Beef Suppliers (broken down by location),

Afghanistan:

Spain- Colomer Spain- Carnicas Voltoya Argentina- JVM

Oman:

Brazil and India Suppliers

UAE:

Indian Products Al Aali Tenderloin. Mirza Tenderloin

Bahrain:

Sulbeef- Brasil Minerva- Brasil Premier Foods- Saudi Arabia

The above is the only information held on beef suppliers, as information for the UK and Europe is a matter for the contractors.
