
Monthly Summary

- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of air quality and dust monitoring undertaken in the London Borough of Brent (LBB) during March and April 2019 respectively.


Figure 1: Current worksites and monitoring locations within the LBB

- 1.1.2 Figure 1 in Appendix A indicates the current worksites together with air quality and dust monitoring locations.
- 1.1.3 This summary should be read in conjunction with the overview monitoring report available from www.gov.uk/government/collections/monitoring-theenvironmental-effects-of-hs2, which highlights: the applicable standards and guidance, as well as the air quality and dust monitoring methodologies to be implemented by nominated undertakers throughout construction.
- 1.1.4 The current phase of works commenced within the LBB during September 2018 and are expected to be completed by July 2019. The current worksite, as presented in Appendix A, Figure 1, includes:
 - Canterbury Road Vent Shaft, securing of site and pre-demolition surveys, worksite ref. S001-WS06.
- 1.1.5 One (1) dust monitor is installed on the worksite, where pre-demolition works are underway. This site returned a high dust risk rating.
- 1.1.6 Dust monitoring locations and results are presented in Appendix B, Table 1, together with line charts of monthly data from each dust monitor in Figure 2.
- 1.1.7 There were no (0) exceedances of the dust trigger level during the month of April 2019.
- 1.1.8 Diffusion tube monitoring of Nitrogen Dioxide (NO₂) was undertaken at four (4) locations in March 2019, around highways within the LBB as part of the management of air quality where significant effects may occur as a result of the scheme.
- 1.1.9 Diffusion tube monitoring results are provided from the laboratory analysis, and therefore still require various analysis and adjustments to be undertaken. Final corrected results will be presented and described in the annual report. However, based on the results to date, no unexpected values were recorded during the monitoring period.

- 1.1.10 NO_2 monitoring locations and results are presented in Appendix C, Table 2, together with the 2019 running mean.
- 1.1.11 There were no complaints received, relating to air quality or dust, during this monitoring period.


