NOTICE OF ORDER WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53

Kent County Council (Bridleways AW378 & AW379, Kingsnorth) Definitive Map Modification Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. Following two earlier exchanges of written representations, the Inspector appointed to determine the Order issued a letter in which she proposed to make further modifications to the Order as drafted. Following advertisement of those proposals, objections / representations have been received.

The start date for the above Order is 25 June 2019.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case which contain evidence in respect of the Inspector's latest proposed modifications only.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statements by adding:

- (i) A bridleway numbered AW378, with a width of 3.0 metres, commencing on Steeds Lane adjacent to the property known as Slab Castle at NGR TR 0130 3797 (point A), which runs generally south-east for approximately 332.0 metres to its connection with the A2070 at NGR TR 0153 3775 (point B). Between the points A-B on the Order plan;
- (ii) A bridleway numbered AW379, with a width of 3.0 metres, commencing at its conclusion with the A2070 at NGR TR 0158 3774 (point C), which crosses the railway lines and runs generally south-east for approximately 240.0 metres and then runs generally north-east for approximately 354.0 metres to its connection with Brockmans Lane at NGR TR 0207 3784 (point D). Between the points C-D on the Order plan. All distances are approximate, all directions are general.

The effect of the previously considered modifications proposed in the Inspector's first interim decision of 27 February 2018 would be to provide for the following modifications:

- •The title of the Order to be amended to refer to Restricted Byways rather than Bridleways;
- ·All references to the Order route in the Order, the Schedule and on the Order Map to be amended to Restricted Byway rather than Bridleway;
- ·In Parts I and II of the Schedule in the descriptions relating to the route AW378, delete the references to the width being 3.0 metres and amend them to 8.0 metres;
- ·In Part I of the Schedule in the description of the route AW379, delete the words 'with a width of 3.0 metres';

- ·In the same paragraph, add the following additional text to the description 'Width between point C and point X 10 metres; width between point X and point D 3.0 metres.';
- ·In Part II of the Schedule at the end of the description of AW379 delete the full stop and add the text 'from Brockmans Lane for a distance of 120 metres and then with a width of 10 metres to the A2070.';
- ·On the Order Map insert point X as shown;
- On the Order Map amend the title the symbol and the key to indicate the status of the route as a Restricted Byway.

The effect of the modifications proposed in the Inspector's further interim decision of 19 February 2019 would be to provide for the following modifications:

- ·In Part 1 of the Schedule, in the second line of the first paragraph delete the words 'Slab Castle' and substitute 'Meadow Farm';
- \cdot In the same paragraph amend the grid reference to read 'NGR TR 0133 3791'
- ·In the same paragraph delete the reference to '332.0' metres and substitute '263.0';
- ·On the Order Map delete the letter 'A' and move it to the new starting point of the Order route opposite Meadow Farm;
- ·Delete the first section of the Order route between the original letter 'A' and the replacement letter 'A'

Within 14 weeks of the start date [by 1 October 2019]

Everyone who has made an objection or representation following the proposed modification(s), the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the above date, the Secretary of State will send copies of the comments received to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the timetable</u> to ensure that statements of case and comments are received on time.
