

NOTICE OF ORDER

Wildlife and Countryside Act

Herefordshire Council

(Addition of Byway Open to All Traffic BZ77 Bosbury) Modification Order 2017

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **6 March 2019**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by adding to them a byway open to all traffic commencing at the B4214 road at OS Grid Reference SO 6765 4398 (point A on the Order plan) and proceeding eastwards along a hedged lane for approximately 177 metres to OS grid reference SO 6783 4400 (point B on the Order plan) then continuing eastward for a further 47 metres to a stone-surfaced lane at OS grid reference SO 6802 4400 (point C on the Order plan), and then continuing eastward along the lane to join the C1152 road at OS Grid Reference SO 6802 4400 (point D on the Order plan). (To be known as Byway Open to All Traffic BZ77). The section between points A and B will have a variable width between 5.4 metres and 8.4 metres, the section between points B and C will have a variable width between 6.2 metres and 12.4 metres and the section between points C and D will have a variable width between 4.0 and 5.4 metres.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date (by 20 March 2019)

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date (by 1 May 2019)

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

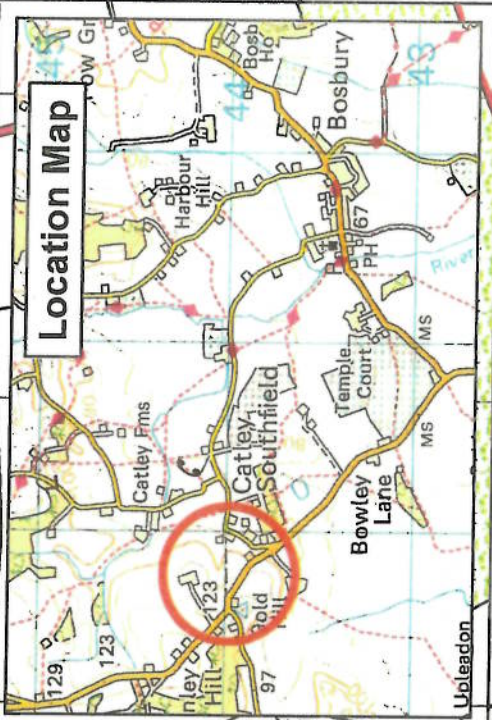
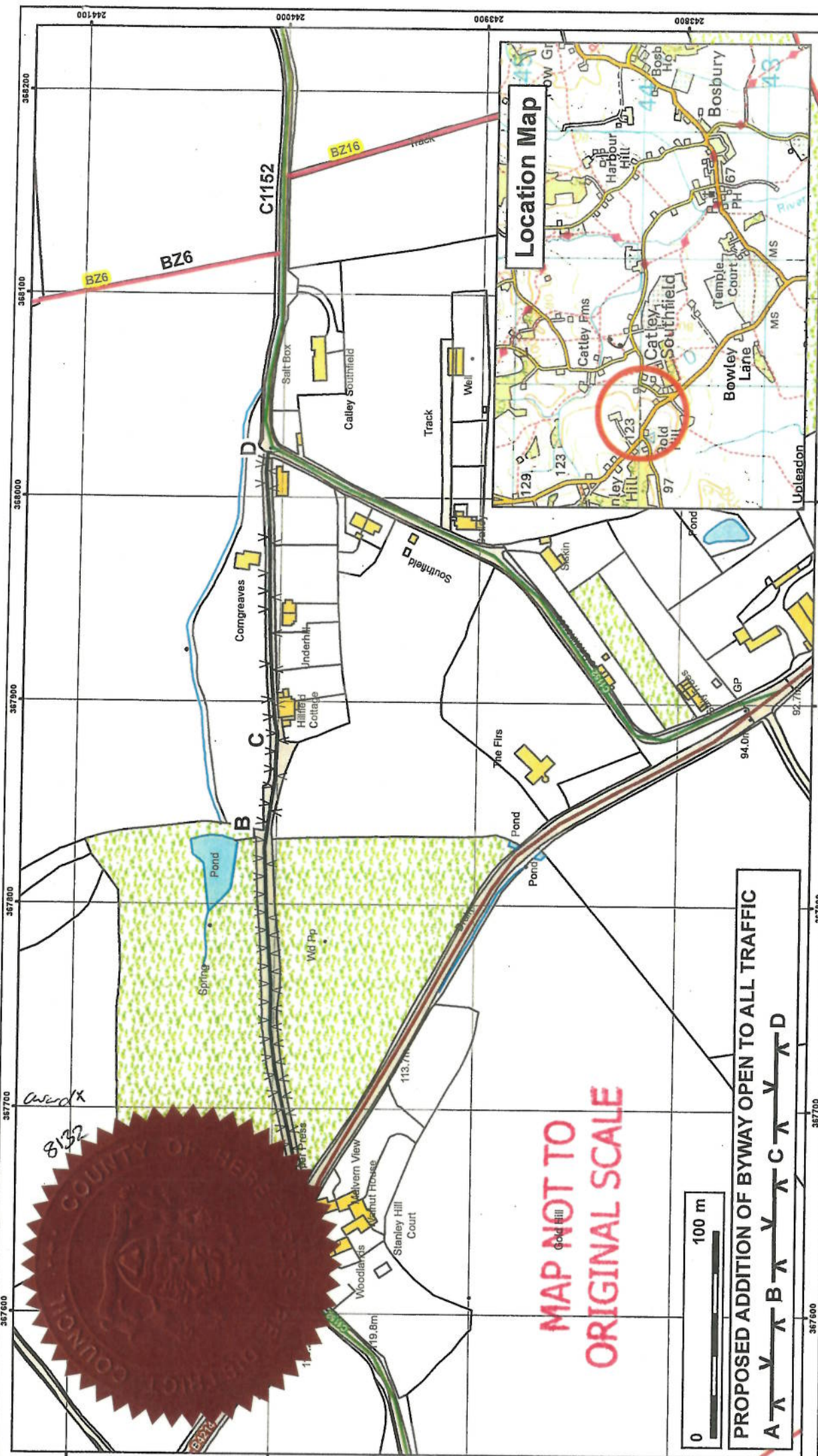
Within 14 weeks of the start date (by 12 June 2019)

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

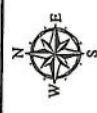
