

Procurement of Civil Legal Aid Services in England and Wales from Autumn 2019: Civil Legal Advice Invitation to Tender

Amendment Notice with effect from 3 July 2019

On 11 June 2019, the LAA published an invitation to tender for Civil Legal Aid Services in England and Wales from Autumn 2019: Civil Legal Advice (CLA) on its e-Tendering portal.

In accordance with paragraph 5.22 of the Information for Applicants document, ("IFA") Applicants are hereby notified that the LAA has amended the IFA to correct the errors as detailed below:

Corrections

1. Amendment 1

IFA paragraph 3.52 The LAA has amended paragraph 3.52 of the IFA to amend the table to clarify that these weightings apply to the Housing & Debt Award Criteria and to insert a second table with the weightings which apply to the Discrimination and Education Award Criteria. These weightings were already set out in Annex C of the IFA.

Paragraph 3.52 now reads:

3.52 The Quality Award Criteria are summarised below and fully set out at Annex C.

2. Amendment 2

IFA paragraph 4.31 The LAA has amended paragraph 4.31 to clarify that the Minimum Quality Threshold applies to sub-criteria 4.2 in the Discrimination and Education Categories of Law and sub-criteria 4.1 in the Housing & Debt Categories as set out in Annex C. Paragraph 4.31 now reads:

4.31 Where an Applicant achieves a non-weighted score of 0 or 1 for the following subcriteria their Tender will be rejected and they will take no further part in the evaluation process:

Housing & Debt Categories - 2.1, 3.2a, or 4.1

Discrimination and Education Categories – 2.1, 3.2a, or 4.2.

3. Amendment 3

IFA paragraph 4.51 The LAA has amended paragraph 4.51 to clarify that sub criteria which are Priority Questions in the Discrimination and Education Categories of Law are 2,1, 3.2a and 4.2 and the sub-criteria which are Priority Questions in the Housing & Debt Categories are 2.1, 3.2a and 4.1. Paragraph 4.51 now reads:

4.51 The sub-criteria which are Priority Questions are set out below:

Housing & Debt Categories:

- 2.1 Supervision of staff delivering specialist legal advice;
- 3.2a) Contract Resourcing;
- 4.1 Implementation Plan.

Discrimination and Education Categories:

- 2.1 Supervision of staff delivering specialist legal advice;
- 3.2a) Contract Resourcing;
- 4.2 Implementation Plan.

4. Amendment 4

IFA Annex D: Quality Award Criteria Guidance The LAA has added a second table to Annex D to reflect that Award Criteria 4 is different for different categories. The first table sets out guidance for Award Criteria 4 for Discrimination and Education Categories. The second table sets out guidance for Award Criteria 4 for Housing & Debt Categories.
