Public Path Diversion Order 2018 Footpath 23 Stock in the City of Chelmsford

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 30 July 2019

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert a part length of public Footpath 23 in the parish of Stock in the City of Chelmsford as shown on the Order Maps contained in these Orders.

A part length of Footpath 23 commencing from grid reference 56971, 19843 at the boundary fence of Broadmore Cottage and running in a south easterly direction for a distance of 67 metres to grid reference 56976, 19839 where it connects to Madles Lane will be diverted to a new route commencing at the same above starting point and running in an easterly then north easterly direction parallel to the south east boundary of the property known as Hunters Moon for a distance of 80 metres to grid reference 56978, 19846 where it connects to the highway known as Whites Hill opposite where Footpath 19 commences.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 13 August 2019]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 24 September 2019]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 5 November 2019]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

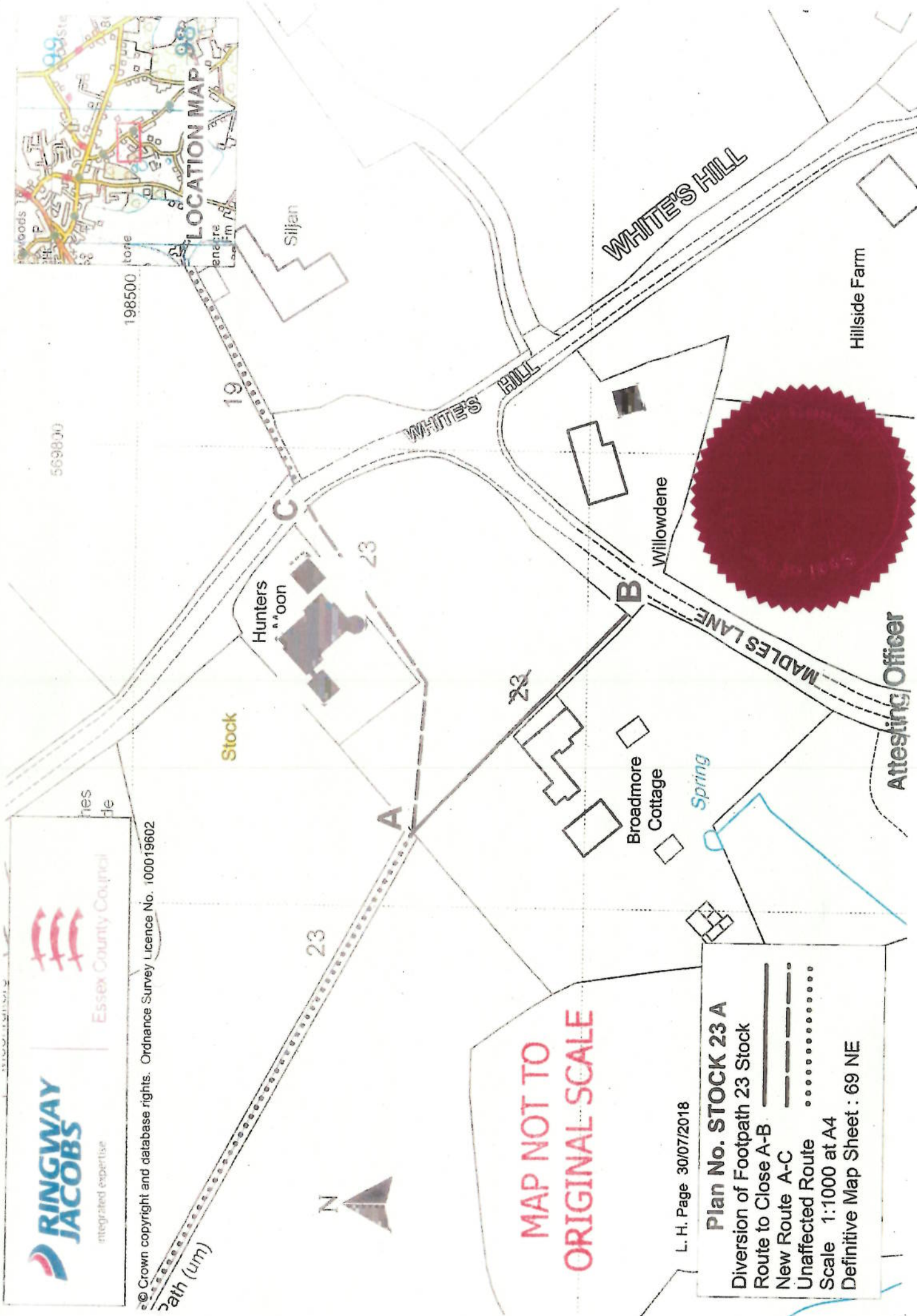
The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Chelmsford City Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated at Broadmore Cottage in Stock known as Footpath 23 Stock in the City of Chelmsford and shown by a bold continuous black line on the order map numbered STOCK 23A contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order

- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated at Broadmore Cottage in Stock known as Footpath 23 Stock in the City of Chelmsford as described in Part 2 of the Schedule and shown by a bold broken black line on the order map numbered STOCK 23A contained in this order.

A part length of Footpath 23 of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 56971,19843 at the boundary fence of Broadmore Cottage running in a south easterly direction for a total distance of approximately 67 metres to point **B** at grid reference 56976,19839 where it connects to Madles Lane.

DESCRIPTION OF SITE OF NEW PATHS OR WAYS

A footpath being 2 metres in width shown by a bold broken black line on the order map commencing at the aforementioned point **A** running in an easterly then north easterly direction parallel to the south east boundary of the property known as Hunters Moon for a total distance of approximately 80 metres to point **C** at grid reference 56978,19846 where it connects to the highway known as Whites Hill opposite where Footpath 19 commences.
