(20 July 2018 - 26 October 2018)

Topline results and codeframe for campaign responses

This document shows topline results and codeframe for responses from members of the public and organisations who responded to the 2018 DIT public consultations, as part of the 38 Degrees organised campaign.

The 38 Degrees campaign was submitted for each of the four DIT consultations on future trade negotiations, representing a total of 583,620 responses overall. Therefore its data has been presented as a separate worksheet.

A total of 145,905 responses were received as part of the 38 Degrees campaign. Some of these contained additional comments (which were subsequently coded), others did not. Coding is the process by which each individual response is matched against a series of themes that DIT and Ipsos MORI compiled, so that the content can be summarised, classified and tabulated. Each of the codes represents a discrete issue or viewpoint raised by a participant or number of participants in their verbatim responses.

The topline shows all bespoke comments made (a total of 52,421). Responses are shown in the form of numbers of responses and not percentages. The consultation ran between 20 July 2018 and 26 October 2018

This topline excludes non-campaign responses, which are included in a separate document.
