## JUDGMENT

1. Upon hearing from the Claimant, I am satisfied that it was not reasonably practicable for the Claimant to present her claim within the period specified by Sub-Section 111(2)(a) and that it was presented within a reasonable time thereafter.
2. The Respondent has failed to present a response within the time limit imposed by Rule 16 to Schedule 1 of the Employment Tribunals (Constitution and Rules of Procedure) Regulations 2013 (the Tribunal rules). Pursuant to rule 21(2) of the Tribunal rules I consider that upon the information provided to me by the Claimant I am able to properly determine the claim.
3. The Claimant's claim for breach of contract by reason of her wrongful dismissal brought pursuant to the Employment Tribunals Extension of Jurisdiction (England and Wales) Order 1994 succeeds. The Respondent is ordered to pay the Claimant the sum of $£ 288.00$ in damages.
4. The Claimant's claim for unlawful deduction of wages brought pursuant to Sections 13 and 23 of the Employment Rights Act 1996 is well founded. I make a declaration to that effect. The Respondent is ordered to pay the Claimant:
4.1.6 day's pay calculated as 8 hours per day at $£ 7.20$ per hour $=£ 345.60$
4.2. The sum of $£ 69.04$ additional loss caused by the failure to pay the sum above.
5. The Claimant's claim for accrued but untaken annual leave brought pursuant to Regulation 30 of the Working Time Regulations 1998 succeeds. The Respondent is ordered to pay the Claimant 10 day's pay calculated as 8 hours per day at $£ 7.20$ per hour $=£ 576$.
6. For the avoidance of doubt the Respondent is ordered to pay the Claimant the total sum of $(£ 288+£ 345.60+£ 69.04+£ 576)=£ 1287.64$
