## **Monthly Summary**

- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of dust monitoring undertaken in the Three Rivers District Council (TRDC) during June 2019.
- 1.1.2 Figure 1 in Appendix A indicates the current worksites together with the dust monitoring locations for June 2019.
- 1.1.3 This summary should be read in conjunction with the overview monitoring report monthly available from <a href="http://www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2">www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2</a>, which highlights: the applicable standards and guidance, as well as the dust monitoring methodology to be implemented by nominated undertakers throughout construction.
- 1.1.4 The current phase of works commenced within TRDC during July 2017 (with monitoring being undertaken by others until June 2019), and are expected to be completed by January 2020. The current worksites, as presented in Appendix A, Figure 1, include:
  - Ongoing construction of compounds and reinforced concrete structures for the Tunnel boring machine power supply. Worksite located both North and South of Chalfont Lane alongside the M25.
  - Ongoing operation and maintenance of site haul road along the western and northern boundaries of site.
  - Installation of perimeter security fencing around boundary of the South Portal field.
  - Ongoing top-soil strip and trial trenching for the purpose of archaeological investigations.
  - Ecology and geotechnical surveys across the field.
- 1.1.5 One (1) dust monitor is installed around worksites, where earthworks, construction and trackout activities are underway. These sites returned a low dust risk rating (for works currently active on site).
- 1.1.6 Dust monitoring locations and results are presented in Appendix B, Table 1, together with a line chart of monthly data from each dust monitor in Figure 2. All continuous dust monitoring is undertaken using indicative monitors. Despite being Environment Agency (MCERTS) certified, indicative monitors carry a higher level of uncertainty than reference monitors, and therefore cannot be strictly compared with Air Quality Standards for human health and the environment. The purpose of the monitoring undertaken is to ensure the effectiveness of the on-site mitigations.
- 1.1.7 The trigger level of 190 μg/m<sup>3</sup>, over a 1-hour period, in accordance with the updated guidance document 'Guidance on Monitoring in the Vicinity of Demolition and Construction Sites October 2018)' has been applied.

- 1.1.8 Data capture for was below 90% for the month of June 2019, as a new monitor was installed and where power supply interruptions were experienced.
- 1.1.9 No (0) dust trigger alerts were recorded during the monitoring period. All results were in line with the expected ranges.
- 1.1.10 There were no complaints, relating to dust or air quality, received during the monitoring period (June 2019).
