## **BANNING ORDER Housing and Planning Act 2016**

Pursuant to sections 14 to 18 of the Housing and Planning Act 2016

The Respondent, David Robert Beattie (date of birth 1st February 1972) of 30 Finchale Avenue, Priorslee, Telford TF2 9YE

With effect from 16th August 2019 until 15th August 2024 is banned from:

- a) Letting housing in England,
- b) Engaging in English letting agency work,
- c) Engaging in English property management work, or
- d) Doing two or more of those things.

and is also banned from being involved in any body corporate that carries out an activity that he is banned by this order from carrying out (for this purpose a person is "involved" in a body corporate if the person acts as an officer of the body corporate or directly or indirectly takes part in or is concerned in the management of the body corporate)

The ban is subject to an exception in relation to the licence/tenancy agreements set out in the Schedule to this Order. The Respondent may continue to act as a residential landlord until the expiry date (or sooner lawful termination) set out in the Schedule in relation to each particular licence/tenancy agreement.

D Jackson Judge of the First-tier Tribunal

Either party may appeal this Order to the Upper Tribunal (Lands Chamber) but must first apply to the First-tier Tribunal for permission. Any application for permission must be in writing, stating grounds relied upon, and be received by the First-tier Tribunal no later than 28 days after the Tribunal sends its written reasons for the Decision to the party seeking permission.
