Direct Healthcare Professional Communication on the use of Irish packs of Voncaspar (pegaspargase) in the UK

Dear Healthcare Professional,

The information in this letter has been agreed between Servier and the Medicines and Healthcare products Regulatory Agency (MHRA).

Summary

Oncaspar 750 U/ml solution for injection/infusion (pegaspargase) will be available on the UK market in Irish packaging from July 2019 to October 2019 (due to supply issues with the UK packaging). There is no difference to the product inside the pack.

- Please ensure that any Pharmacovigilance Information or medical enquiries for a UK patient are reported through the MHRA yellow card or directly to Servier Laboratories Ltd. (see «Call for reporting» and «Communication Information» below).
- The Irish cartons will meet serialisation requirements. The Global Trade Item Number (GTIN) of the Irish packs to be placed on the UK market, will be uploaded into the EU Hub and in turn diffused to the UK National Database. Therefore, no error message will appear when the Irish packs will be scanned for decommissioning at UK hospital level.

Prescribers

The product in the pack has not changed; there should be no effect on prescribing.

Oncaspar is indicated as a component of antineoplastic combination therapy in acute lymphoblastic leukaemia (ALL) in paediatric patients from birth to 18 years, and adult patients. Oncaspar is authorised for use in the European Union.
