This introductory note does not form a part of the notice.

The following notice gives notice of the surrender in part of an environmental permit.

Viridor Waste Management Limited have surrendered part of the Trigon Hill Landfill Site, the area surrendered is on the western extremity of the permitted site area and the surrender will encompass all permitted activities on the area. This is a low risk surrender due to the nature of the activities undertaken on this area. The site qualifies as low risk as the only materials deposited in the area are inert materials and unpolluted soil from extraction of mineral that were excavated from elsewhere on site and no waste materials imported into the area.


