

NOTICE OF ORDER HIGHWAYS ACT 1980 Section 26

The Cheshire West and Chester Borough Council (Footpath 52 Ellesmere Port)
Public Path Creation Order 2018

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 28 October 2019

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to create a footpath in Ellesmere Port commencing at Footpath 17 Ellesmere Port at OS grid reference SJ 3702 7763 (point A on Plan C35B) and running in a generally north easterly direction for approximately 263 metres to a point on the east side of the corner of fencing bounding land forming the sports fields at OS grid reference SJ 3719 7781.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 11 November 2019]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 23 December 2019]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 3 February 2020]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

ELLESMERE PORT) PUBLIC PATH CREATION ORDER 2018**

This Order is made by Cheshire West and Chester Borough Council ("the Authority") under Section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that having regard to the matters set out in section 26(1) there is a need for a public footpath over the land to which this order relates, and that it is expedient that the way should be created.

The Authority has consulted with every local authority whose area includes the land to which the Order relates.

BY THIS ORDER:

1. There shall be at the end of 10 days from the date of confirmation of this order a public footpath over the land at Ellesmere Port described in Part I of the Schedule to this order and shown by a broken black line on the map attached to this order.

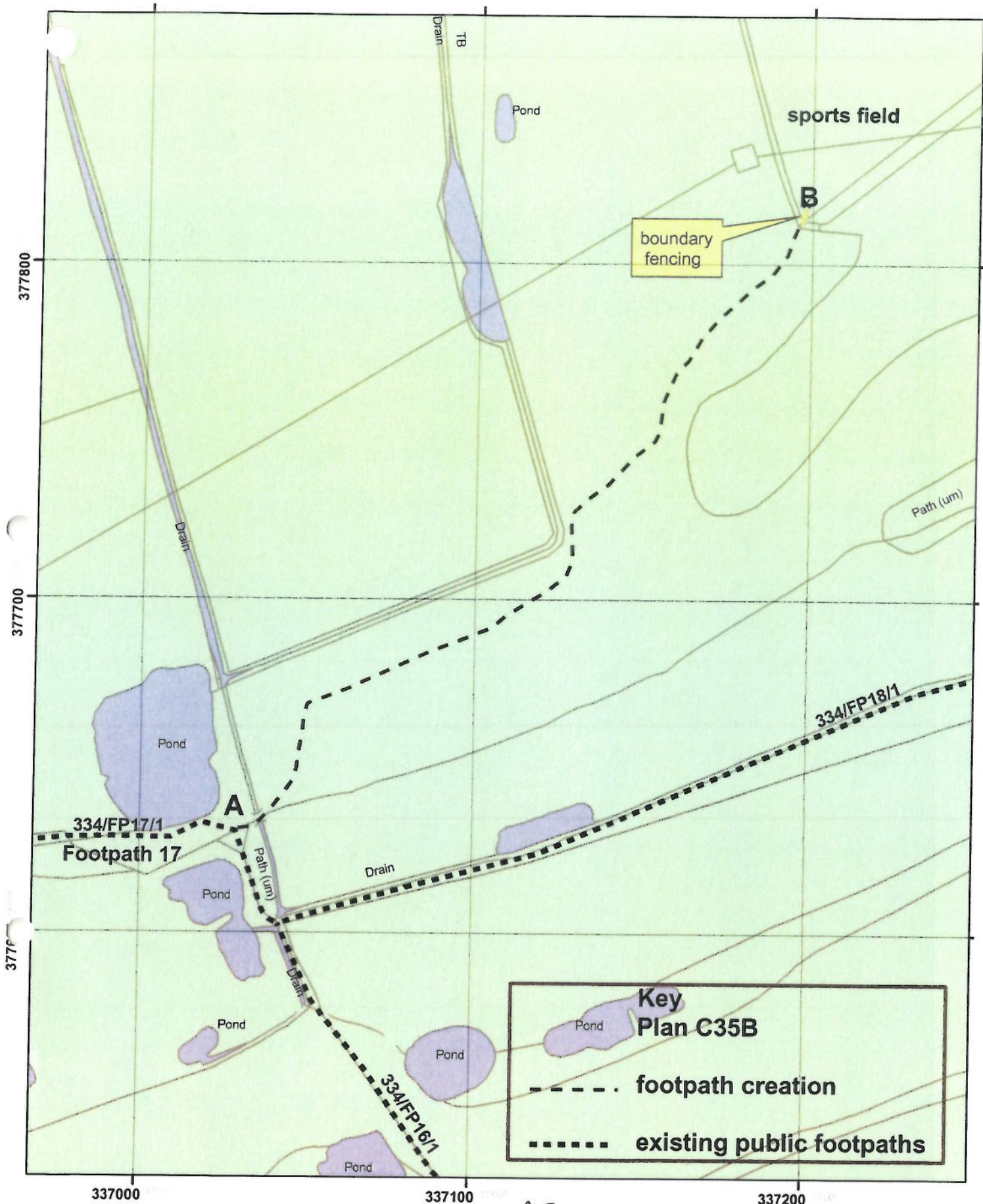
SCHEDULE

PART 1

Description of Land

A footpath in Ellesmere Port commencing at Footpath 17 Ellesmere Port at OS grid reference SJ 3702 7763 (point A on Plan C35B) and running in a generally north easterly direction for approximately 263 metres to a point on the east side of the corner of fencing bounding land forming the sports fields at OS grid reference SJ 3719 7781 (Point B on Plan C35B) as indicated by a broken black line between points A and B on Plan C35B

A total distance of 263 metres. The footpath running between points A and B on plan No C35B is 2 metres wide throughout.
