¹STATEMENT OF CHANGES IN IMMIGRATION RULES

The Home Secretary has made the changes hereinafter stated in the rules laid down by them as to the practice to be followed in the administration of the Immigration Acts for regulating entry into and the stay of persons in the United Kingdom and contained in the statement laid before Parliament on 23 May 1994 (HC 395) as amended. Implementation

The changes set out in this statement to Part 9 shall take effect on 31 October 2019.

The changes set out in this statement to Appendix EU shall take effect:

- (i) subject to sub-paragraph (ii), below, on 31 October 2019; and
- (ii) in relation to applications made under Part 2 of Appendix EU:
 - (a) on the later of 31 October 2019 or the date on which the United Kingdom withdraws from the European Union without a Withdrawal Agreement, as defined in Annex A to Part 2, where the applicant is an 'EEA citizen' (as defined in Annex A); and
 - (b) on the later of 4 December 2019 or a date thereafter on which the United Kingdom withdraws from the European Union without a Withdrawal Agreement, as defined in Annex A to Part 2, where the applicant is a 'relevant family member' (as defined in Annex A).

The changes set out in this statement to Appendix EU (Family Permit) shall take effect on 31 October 2019.

The changes set out in this statement to Appendix AR (EU) shall take effect on 4 December 2019 and will apply in respect of applications made under Appendix EU on or after that date.

Review

Before the end of each review period, the Secretary of State undertakes to review all of the relevant Immigration Rules including any Relevant Rule amended or added by these changes. The Secretary of State will set out the conclusions of the review in a report and publish the report.

The report must in particular:

(a) consider each of the Relevant Rules and whether or not each Relevant Rule

- achieves its objectives and is still appropriate; and
- (b) assess whether those objectives remain appropriate and, if so, the extent to which they could be achieved with a system that imposes less regulation.

"Review period" means:

- (a) the period of five years beginning on 6 April 2017; and
- (b) subject to the paragraph below, each successive period of five years.

If a report under this provision is published before the last day of the review period to which it relates, the following review period is to begin with the day on which that report is published.

"Relevant Rule" means an Immigration Rule which:

- (a) imposes requirements, restrictions or conditions, or sets standards, in relation to any activity carried on by a business or voluntary or community body; or
- (b) relates to the securing of compliance with, or the enforcement of, requirements, restrictions, conditions or standards which relate to any activity carried on by a business or voluntary or community body.

Changes to Part 9

- 9.1 For paragraph D320., substitute:
 - "D320(1). Part 9 does not apply to applications made under Appendix EU (Family Permit).
 - (2) Part 9 does not apply to applications made under Part 1 of Appendix EU.
 - (3) Part 9 does not apply to applications made under Part 2 of Appendix EU, except for paragraphs 322(1E) and (13), which apply to such applications, regardless of the application of paragraph 5 of these Rules.".
- 9.2 In paragraph E320., for sub-paragraph (3), substitute:
 - "(3) Part 9 does not apply to leave to enter or remain that was granted by virtue of Part 1 of Appendix EU, except for paragraphs 321B, 323(i), 323(ia), and 323(ii), which apply to such leave, regardless of the application of paragraph 5 of these Rules.
 - (4) Part 9 does not apply to leave to remain that was granted by virtue of Part 2 of Appendix EU, except for paragraphs 321B, 323(i), 323(ia), 323(ii), 323(iv), 323(vi) and 323(vii), which apply to such leave, regardless of the

application of paragraph 5 of these Rules.".

9.3 After paragraph E320., insert:

- "F320(1). If the UK leaves the European Union without a Withdrawal Agreement (as defined in Annex 1 to Part 1 of Appendix EU), and to the extent that the European Community Association Agreement with Turkey (ECAA) is disapplied by Chapter 5 of Part 2 of the Immigration, Nationality and Asylum (EU Exit) Regulations 2019, including any rights, powers, liabilities, obligations, restrictions, remedies and procedures derived from that agreement, Part 9 does not apply to:
- (a) Applications for entry clearance or limited leave to enter or remain by virtue of the ECAA, except for paragraphs 320(2), 320(6), 320(7A), 320(7B), 320(7BB), 320(11), 320(18A), 320(18B), 320(19), 320(22) and 320(23), and 322(1B), 322(2), 322(2A), 322(3), 322(5), 322(5A), 322(12) and 322(13), which apply to such applications where the relevant decision falls within subparagraph (2); or
- (b) Limited leave to enter or remain which was granted by virtue of the ECAA, except for paragraphs 321C, 323(i) and 323(ia), which apply to such leave where the relevant decision falls within sub-paragraph (2).
- (2) A decision falls within this sub-paragraph where:
- (a) It is being made in respect of a person who did not have entry clearance or limited leave to enter or remain by virtue of the ECAA immediately before the date and time of the UK's withdrawal from the European Union; or
- (b) It is being made in respect of a person who did have entry clearance or limited leave to enter or remain in the UK by virtue of the ECAA immediately before the date and time of the UK's withdrawal from the European Union and either:
 - (i) The decision is based on conduct committed after the date and time of withdrawal; or
 - (ii) The decision is based on conduct committed before or after the date and time of withdrawal, and the person to whom the decision relates has been convicted of an offence in respect of conduct committed after the date and time of withdrawal, which has resulted in a sentence of imprisonment.".
- 9.4 For paragraph 321B., substitute:
 - "321B. A person's leave to enter or remain which is in force on their arrival in or while they are outside the United Kingdom may be cancelled:

- (a) If that person has leave to enter or remain in the United Kingdom granted by virtue of Appendix EU, or leave to enter the United Kingdom granted by virtue of having arrived in the United Kingdom with an entry clearance that was granted under Appendix EU (Family Permit); and
- (b)(i) The cancellation is justified on grounds of public policy, public security or public health in accordance with regulation 27 of the Immigration (European Economic Area) Regulations 2016, irrespective of whether those Regulations apply to that person (except that for "a right of permanent residence under regulation 15" read "indefinite leave to enter or remain"; and for "EEA decision" read "a decision under paragraph 321B of the Immigration Rules"); or
- (ii) Their leave to enter or remain in the United Kingdom was granted by virtue of Part 1 of Appendix EU, or their leave to enter the United Kingdom was granted by virtue of having arrived in the United Kingdom with an entry clearance that was granted under Appendix EU (Family Permit), and cancellation is justified on the ground that, the United Kingdom having withdrawn from the European Union without a Withdrawal Agreement (as defined in Annex 1 to Part 1 of Appendix EU), cancellation is conducive to the public good:
- (aa) on the basis of the person's conduct committed after the date and time of withdrawal; or
- (bb) on the basis of the person's conduct committed before or after the date and time of withdrawal, where:
 - (aaa) their leave (or, in the case of a person with leave to enter granted by virtue of having arrived in the United Kingdom with an entry clearance that was granted under Appendix EU (Family Permit), their entry clearance) was not granted on the basis that they are a specified EEA citizen (as defined in Annex 1 to Part 1 of Appendix EU or, as the case may be, in Annex 1 to Appendix EU (Family Permit)) or their family member (falling within the definition of family member of a relevant EEA citizen as defined in Annex 1 to Part 1 of Appendix EU or, as the case may be, in Annex 1 to Appendix EU (Family Permit)); and
 - (bbb) their conduct committed after the date and time of withdrawal has resulted in a sentence of imprisonment; or
- (iii) Their leave to remain was granted by virtue of Part 2 of Appendix EU and cancellation is justified on the ground that it is conducive to the public good; or

- (iv) The cancellation is justified on grounds that, in relation to the relevant application under Appendix EU or Appendix EU (Family Permit), and whether or not to the applicant's knowledge, false or misleading information, representations or documents were submitted (including false or misleading information submitted to any person to obtain a document used in support of the application); and the information, representation or documentation was material to the decision to grant the applicant leave to enter or remain under Appendix EU or (as the case may be) an entry clearance under Appendix EU (Family Permit); or
- (v) Their leave to enter or remain was granted by virtue of Appendix EU and they cease to meet the requirements of that Appendix.".

9.5 After paragraph 321B., insert:

- "321C. Subject to paragraph F320, a person's limited leave to enter or remain granted by virtue of the European Community Association Agreement with Turkey (ECAA), which is in force on their arrival in or while they are outside the United Kingdom may be cancelled:
- (a) If the cancellation is justified on the ground that it is conducive to the public good; or
- (b) If the cancellation is justified on grounds that, in relation to the relevant application for entry clearance or limited leave to enter or remain by virtue of the ECAA, and whether or not to the applicant's knowledge, false or misleading information, representations or documents were submitted (including false or misleading information submitted to any person to obtain a document used in support of the application); and the information, representation or documentation was material to the decision to grant the applicant entry clearance or limited leave to enter or remain by virtue of the ECAA.".

9.6 In paragraph 323., for sub-paragraph (i), substitute:

"(i) on any of the grounds set out in paragraph 322(2)-(5A) above (except where this paragraph applies in respect of a person granted leave under Appendix Armed Forces, where "paragraph 322(2)-(5A) above" is to read as if it said "paragraph 322(2) and (3) above and paragraph 8(e) and (g) of Appendix Armed Forces"; and except where this paragraph applies in respect of a person granted leave to enter or remain under Part 1 of Appendix EU or granted leave to enter by virtue of having arrived in the UK with an entry clearance that was granted under Appendix EU (Family Permit), where "paragraph 322(2)-(5A) above" is to read as if it said "paragraph 322(2)-(2A)"; and except where this paragraph applies in respect of a person granted leave to remain under Part 2 of Appendix EU, where "paragraph 322(2)-(5A) above" is to read as if it said "paragraph 322(2)-(5A)"; and

except where this paragraph applies in respect of a person who has been granted limited leave to enter or remain by virtue of the European Community Association Agreement with Turkey, where "paragraph 322(2)-(5A) above" is to read as if it said "paragraph 322(2)-(3), 322(5) and 322(5A))"; or".

9.7 In paragraph 323., for sub-paragraph (vi), substitute:

"(vi) if the person was granted their current period of leave as the dependant of (or, under Part 2 of Appendix EU, as the relevant family member of) a person ("P") and P's leave to enter or remain is being, or has been, curtailed; or".

Changes to Appendix AR (EU)

AR(EU)1.1 For paragraph AR(EU)1.1., substitute:

- "AR(EU)1.1. An applicant may only apply for an administrative review where an eligible decision has been made under Appendix EU, an eligible decision being a decision to:
- (a) Refuse their application under paragraph EU6 of Part 1 of Appendix EU because the applicant does not meet the eligibility requirements for indefinite leave to enter or remain under paragraph EU11 or EU12 or for limited leave to enter or remain under paragraph EU14; or
- (b) Grant limited leave to enter or remain under paragraph EU3 of Part 1 of Appendix EU and not indefinite leave to enter or remain under paragraph EU2; or
- (c) Refuse their application under paragraph ETLR5 of Part 2 of Appendix EU.".

AR(EU)1.2 For paragraph AR(EU)1.2., substitute:

- "AR(EU)1.2. An applicant may not apply for an administrative review where a decision has been made under Appendix EU to:
- (a) Refuse their application under paragraph EU6 of Part 1 on suitability grounds as set out in paragraph EU15 or EU16; or
- (b) Refuse their application under paragraph ETLR5 of Part 2 on suitability grounds as set out in paragraph ETLR12, ETLR13 or ETLR14.".

AR(EU)1.3 For paragraph AR(EU)1.3., substitute:

"AR(EU)1.3. An applicant may not apply for an administrative review where their application under Appendix EU has been rejected as invalid under

paragraph EU10(1) of Part 1 or under paragraph ETLR10(1) of Part 2.".

AR(EU)1.4 In paragraph AR(EU)2.1., for sub-paragraph (c), substitute:

"(c) Information or evidence that was not before the decision-maker has been provided to the reviewer which shows that the applicant qualifies for a grant, or (in respect of an application made under Part 1) for a different grant, of leave under Appendix EU.".

Changes to Appendix EU

EU1.1 For Appendix EU, substitute:

"Appendix EU: EU, other EEA and Swiss citizens and family members

Part 1 – EU Settlement Scheme

Purpose

EU1. This Part of this Appendix sets out the basis on which an **EEA citizen** and their family members, and the family members of a **qualifying British citizen**, will, if they apply under it, be granted indefinite leave to enter or remain or limited leave to enter or remain.

Requirements and procedure

- EU2. The applicant will be granted indefinite leave to enter (where the application is made outside the UK) or indefinite leave to remain (where the application is made within the UK) where:
 - A valid application has been made in accordance with paragraph EU9;
 - The applicant meets the eligibility requirements for indefinite leave to enter or remain in accordance with paragraph EU11 or EU12; and
 - The applicant is not to be refused on grounds of suitability in accordance with paragraph EU15 or EU16.
- EU3. The applicant will be granted five years' limited leave to enter (where the application is made outside the UK) or five years' limited leave to remain (where the application is made within the UK) where:
 - A valid application has been made in accordance with paragraph EU9;
 - The applicant does not meet the eligibility requirements for indefinite leave to enter or remain in accordance with paragraph EU11 or EU12, but meets the eligibility requirements for limited leave to enter or remain in accordance with paragraph EU14; and
 - The applicant is not to be refused on grounds of suitability in accordance with paragraph EU15 or EU16.

- EU4. Where a person has been granted limited leave to enter or remain under this Part of this Appendix:
 - They must continue to meet the eligibility requirements for that leave which they met at the **date of application** (except for any which related to their dependency as a **child**, **dependent parent** or **dependent relative**) or meet other eligibility requirements for limited leave to enter or remain in accordance with paragraph EU14; and
 - They remain able to apply for indefinite leave to enter or remain under this Part of this Appendix and will be granted this where the requirements in paragraph EU2 are met.
- EU5. Where a person has been granted indefinite leave to enter or remain or limited leave to enter or remain under this Part of this Appendix and that person also has a right to enter or reside under the **EEA Regulations**, the leave does not have effect to the person's detriment in so far as the leave is incompatible with that right to enter or reside for as long as that person has that right.
- EU6. A valid application made under this Part of this Appendix which does not meet the requirements for indefinite leave to enter or remain or limited leave to enter or remain will be refused.
- EU7. Annex 1 and Annex 2 set out definitions which apply to this Part of this Appendix. Any provision made elsewhere in the Immigration Rules for those terms, or for other matters for which this Part of this Appendix makes provision, does not apply to an application made under this Part of this Appendix.
- EU8. Annex 3 applies to the consideration by the Secretary of State of a valid application made under this Part of this Appendix.

Valid application

- EU9. A valid application has been made under this Part of this Appendix where:
 - (a) It has been made using the **required application process**;
 - (b) The **required proof of identity and nationality** has been provided, where the application is made within the UK;
 - (c) The required proof of entitlement to apply from outside the UK has been provided, where the application is made outside the UK; and
 - (d) The **required biometrics** have been provided.

- EU10. (1) An application made under this Part of this Appendix will be rejected as invalid where it does not meet the requirements in paragraph EU9.
 - (2) In paragraph 34BB of these Rules, sub-paragraphs (3) to (5) do not apply to applications made under this Part of this Appendix.

Eligibility for indefinite leave to enter or remain

Persons eligible for indefinite leave to enter or remain as a relevant EEA citizen or their family member, or as a person with a derivative right to reside or with a Zambrano right to reside

EU11. The applicant meets the eligibility requirements for indefinite leave to enter or remain as a **relevant EEA citizen** or their family member (or as a **person with a derivative right to reside** or a **person with a Zambrano right to reside**) where the Secretary of State is satisfied, including (where applicable) by the **required evidence of family relationship**, that, at the date of application, one of conditions 1 to 7 set out in the following table is met:

(b) The applicant has completed a continuous qualifying period of five

Annex 3 – Consideration of a valid application

A3.1. A valid application made under this Part of this Appendix will be

decided on the basis of:

- (a) the information and evidence provided by the applicant, including in response to any request for further information or evidence made by the Secretary of State; and
- (b) any other information or evidence made available to the Secretary of State (including from other government departments) at the date of decision.
- A3.2. (1) For the purposes of deciding whether the applicant meets the eligibility requirements for indefinite leave to enter or remain or for limited leave to enter or remain, the Secretary of State may:
 - (a) request that the applicant provide further information or evidence that they meet those requirements; or
 - (b) invite the applicant to be interviewed by the Secretary of State in person, by telephone, by video-telecommunications link or over the internet.
 - (2) If the applicant purports to meet the eligibility requirements for indefinite leave to enter or remain or for limited leave to enter or remain on the basis of a relationship with another person ("P"), including where P is a qualifying British citizen, the Secretary of State may:
 - (a) request that P provide information or evidence about their relationship with the applicant, their residence in the UK or, where P is a qualifying British citizen, their residence in a country listed in subparagraph (a)(i) of the entry for 'EEA citizen' in the table at Annex 1 to this Part of this Appendix; or
 - (b) invite P to be interviewed by the Secretary of State in person, by telephone, by video-telecommunications link or over the internet.
 - (3) If the applicant or P (as the case may be):
 - (a) fails within a reasonable timeframe specified in the request to provide the information or evidence requested; or
 - (b) on at least two occasions, fails to comply with an invitation to attend an interview in person or with other arrangements to be interviewed,

the Secretary of State may draw any factual inferences about whether the applicant meets the eligibility requirements for indefinite leave to enter or remain or for limited leave to enter or remain as appear appropriate in the circumstances.

- (4) The Secretary of State may decide, following the drawing of a factual inference under sub-paragraph (3), that the applicant does not meet the eligibility requirements for indefinite leave to enter or remain or for limited leave to enter or remain.
- (5) The Secretary of State must not decide that the applicant does not meet the eligibility requirements for indefinite leave to enter or remain or for limited leave to enter or remain on the sole basis that the applicant or P failed on at least two occasions to comply with an invitation to be interviewed.

Part 2 – European Temporary Leave to Remain

Purpose

ETLR1. This Part of this Appendix sets out the basis on which, where the United Kingdom has withdrawn from the European Union without a **Withdrawal Agreement**, an **EEA citizen** and their family members, and the family members of an **Irish citizen**, will, if they apply under it, be granted **European Temporary Leave to Remain**.

ETLR2. This Part of this Appendix does not have effect in connection with the residence scheme that operates in connection with the withdrawal of the United Kingdom from the European Union, and so does not constitute "residence scheme immigration rules" (see for example section 33 of the UK Borders Act 2007 and regulation 2 of the Immigration (European Economic Area) Regulations 2016).

Requirements and procedure

- ETLR3. The applicant will be granted European Temporary Leave to Remain, of the duration and subject to the conditions set out in paragraph ETLR4, where:
 - (a) The applicant has not previously been granted European Temporary Leave to Remain;
 - (b) A valid application has been made in accordance with paragraphs ETLR8 and ETLR9;
 - (c) The applicant meets the eligibility requirements in accordance with paragraph ETLR11; and
 - (d) The applicant is not to be refused on grounds of suitability in accordance with paragraphs ETLR12 to ETLR14.

ETLR4. (1) Where the applicant is:

- (a) An EEA citizen; and
- (b) The date of application is before 1 January 2021,

European Temporary Leave to Remain will, subject to sub-paragraph (4), be granted for a period of 36 months from the date of decision.

- (2) Where the applicant is a **relevant family member** of a **relevant EEA citizen**, European Temporary Leave to Remain will, subject to sub-paragraph (4), be granted for a period equal, as at the date of decision, to the remaining period of the European Temporary Leave to Remain granted to the relevant EEA citizen.
- (3)(a) Where the applicant is:
 - (i) A relevant family member of an Irish citizen; and
 - (ii) The date of application is before 1 January 2021,

European Temporary Leave to Remain will, subject to sub-paragraph (4), be granted for a period of 36 months from the date of decision.

- (b) Where the applicant is:
 - (i) A relevant family member of an Irish citizen; and
 - (ii) The date of application is on or after 1 January 2021,

European Temporary Leave to Remain will be granted until 31 December 2023.

- (4) The date on which a grant of European Temporary Leave to Remain will expire may not be after 31 December 2023.
- (5) The duration of a grant of European Temporary Leave to Remain may not be extended.
- (6) A person granted European Temporary Leave to Remain must continue to meet the eligibility requirements for that leave which they met at the **date of application** (unless that leave was granted on the basis that the applicant was a **child**).
- (7) A person granted European Temporary Leave to Remain must occupy **adequate accommodation** for the duration of that leave.

- (8) Where a person granted European Temporary Leave to Remain also has a right to enter or reside under the **EEA Regulations**, the leave does not have effect to the person's detriment in so far as the leave is incompatible with that right to enter or reside for as long as that person has that right.
- ETLR5. A valid application made under this Part of this Appendix which does not meet the requirements for European Temporary Leave to Remain will be refused.
- ETLR6. Annex A sets out definitions which apply to this Part of this Appendix. Any provision made elsewhere in the Immigration Rules for those terms, or for other matters for which this Part of this Appendix makes provision, does not apply to an application made under this Part of this Appendix.
- ETLR7. Annex B applies to the consideration by the Secretary of State of a valid application made under this Part of this Appendix.

Valid application

ETLR8. A valid application has been made under this Part of this Appendix where:

- (a) It has been made in the UK using the required application process;
- (b) The required proof of identity and nationality has been provided;
- (c) The required biometrics have been provided; and
- (d) In addition, where the applicant is:
 - (i) A relevant family member of a relevant EEA citizen:
 - (aa) The **Unique Application Number** for the relevant EEA citizen has been provided;
 - (bb) The Unique Application Number for the **spouse**, **civil partner** or **partner** of the relevant EEA citizen has been provided, where the applicant is a child of that spouse, civil partner or partner (unless that person has died);
 - (cc) A **relevant document** for the applicant has been provided, unless the applicant is a child who was born in the UK; and
 - (dd) The **required evidence of family relationship** has been provided; or

- (ii) A relevant family member of an Irish citizen:
 - (aa) A copy of the Irish citizen's valid passport or valid national identity card as an Irish citizen has been provided and, where the Secretary of State has reasonable doubt as to the authenticity of the copy submitted, the Secretary of State can require the applicant to submit the original document;
 - (bb) The Unique Application Number for the spouse, civil partner or partner of the Irish citizen has been provided, where the applicant is a child of that spouse, civil partner or partner (unless that person has died);
 - (cc) A relevant document for the applicant has been provided, unless the applicant is a child who was born in the UK; and
 - (dd) The required evidence of family relationship has been provided.
- ETLR9. Where the applicant is under the age of 18 years, the application must be accompanied by evidence that it has been made with the consent of the applicant's parents (or of one parent where they have sole legal responsibility for the applicant), of the applicant's legal guardian or of the local authority or health and social care trust with parental responsibility for the applicant.
- ETLR10. (1) An application made under this Part of this Appendix will be rejected as invalid where it does not meet the requirements in paragraph ETLR8 or ETLR9.
 - (2) In paragraph 34BB of these Rules, sub-paragraphs (3) to (5) do not apply to applications made under this Part of this Appendix.

Eligibility

- ETLR11. The applicant meets the eligibility requirements for European Temporary Leave to Remain where the Secretary of State is satisfied that, at the date of application, the applicant is resident in the UK, and is:
 - (a) An EEA citizen and the date of application is before 1 January 2021; or
 - (b) A relevant family member of a relevant EEA citizen and the date of application is before the date of expiry of any European Temporary Leave to Remain granted to the relevant EEA citizen; or
 - (c) A relevant family member of an Irish citizen and the date of

Suitability

- ETLR12. (1) An application made under this Part of this Appendix will be refused on grounds of suitability where any of the following apply at the date of decision:
 - (a) The applicant is subject to a **deportation order** or to a decision to make a deportation order; or
 - (b) The applicant is subject to an **exclusion order** or **exclusion decision**.
 - (2) An application made under this Part of this Appendix may be refused on grounds of suitability where any of the following apply at the date of decision:
 - (a) The applicant is subject to an Islands deportation order; or
 - (b) The applicant is subject to an **Islands exclusion decision**.
 - ETLR13. An application made under this Part of this Appendix may be refused on grounds of suitability where, at the date of decision, the Secretary of State is satisfied that it is proportionate to refuse the application where:
 - (a) In relation to the application and whether or not to the applicant's knowledge, false or misleading information, representations or documents have been submitted (including false or misleading information submitted to any person to obtain a document used in support of the application); and the information, representation or documentation is material to the decision whether or not to grant the applicant European Temporary Leave to Remain under this Part of this Appendix; or
 - (b) The applicant is subject to a removal decision under the EEA Regulations on the grounds of their non-exercise or misuse of rights under Directive 2004/38/EC; or
 - (c) The refusal of the application is justified on the ground that the decision is conducive to the public good.
- ETLR14. An application made under this Part of this Appendix may be refused on the grounds of suitability in accordance with Part 9 of these Rules as applied to an application made under this Part of this Appendix by paragraph D320(3).
- ETLR15. The references in paragraphs ETLR12 and ETLR13 to an order or

decision to which the applicant is subject do not include an order or decision which, at the date of decision on their application under this Part of this Appendix, has been set aside or no longer has effect in respect of the applicant.

Annex B - Consideration of a valid application

B1. A valid application made under this Part of this Appendix will be

decided on the basis of:

- (a) the information and evidence provided by the applicant, including in response to any request for further information or evidence made by the Secretary of State; and
- (b) any other information or evidence made available to the Secretary of State (including from other government departments) at the date of decision.
- B2. (1) For the purposes of deciding whether the applicant meets the eligibility requirements for European Temporary Leave to Remain, the Secretary of State may:
 - (a) request that the applicant provide further information or evidence that they meet those requirements; or
 - (b) invite the applicant to be interviewed by the Secretary of State in person, by telephone, by video-telecommunications link or over the internet.
 - (2) If the applicant purports to meet the eligibility requirements for European Temporary Leave to Remain on the basis of a relationship with another person ("P"), the Secretary of State may:
 - (a) request that P provide information or evidence about their relationship with the applicant or their residence in the UK; or
 - (b) invite P to be interviewed by the Secretary of State in person, by telephone, by video-telecommunications link or over the internet.
 - (3) If the applicant or P (as the case may be):
 - (a) fails within a reasonable timeframe specified in the request to provide the information or evidence requested; or
 - (b) on at least two occasions, fails to comply with an invitation to attend an interview in person or with other arrangements to be interviewed.

the Secretary of State may draw any factual inferences about whether the applicant meets the eligibility requirements for European Temporary Leave to Remain as appear appropriate in the circumstances.

(4) The Secretary of State may decide, following the drawing of a factual inference under sub-paragraph (3), that the applicant does not meet the eligibility requirements for European Temporary Leave to

Remain.

(5) The Secretary of State must not decide that the applicant does not meet the eligibility requirements for European Temporary Leave to Remain on the sole basis that the applicant or P failed on at least two occasions to comply with an invitation to be interviewed.".

Changes to Appendix EU (Family Permit)

EU(FP)1.1 For Appendix EU (Family Permit), substitute:

"Appendix EU (Family Permit)

Purpose

- FP1. This Appendix sets out the basis on which a **non-EEA citizen** will, if they apply under it, be granted an entry clearance:
 - (a) In the form of an EU Settlement Scheme Family Permit to join a **relevant EEA citizen** in the UK or to accompany them to the UK; or
 - (b) In the form of an EU Settlement Scheme Travel Permit to travel to the UK.
- FP2. This Appendix has effect in connection with the granting of entry clearance for the purposes of acquiring leave to enter or remain in the UK by virtue of Part 1 of Appendix EU to these Rules.

Requirements and procedure

- FP3. The applicant will be granted an entry clearance under this Appendix, valid for a period of six months from the date of decision, by an entry clearance officer where:
 - (a) A valid application has been made in accordance with paragraph FP4;
 - (b) The applicant meets the eligibility requirements in paragraph FP6(1) or (2); and
 - (c) The applicant is not to be refused on grounds of suitability in accordance with paragraph FP7.
- FP4. A valid application has been made under this Appendix where:
 - (a) It has been made using the **required application process**;
 - (b) The required proof of identity and nationality has been provided; and

- (c) The **required biometrics** have been provided.
- FP5. An application will be rejected as invalid where it does not meet the requirements in paragraph FP4(a) and (b), and will not be considered where it does not meet the requirement in paragraph FP4(c).
- FP6. (1) The applicant meets the eligibility requirements for an entry clearance to be granted under this Appendix in the form of an EU Settlement Scheme Family Permit, where the entry clearance officer is satisfied that at the **date of application**:
 - (a) The applicant is a non-EEA citizen;
 - (b) The applicant is a family member of a relevant EEA citizen;
 - (c) The relevant EEA citizen is resident in the UK or will be travelling to the UK within six months of the date of application;
 - (d) The applicant will be accompanying the relevant EEA citizen to the UK or joining them in the UK; and
 - (e) The applicant ("A") is not the **spouse**, **civil partner** or **durable partner** of a relevant EEA citizen ("B") where a spouse, civil partner or durable partner of A or B has been granted an entry clearance under this Appendix, holds a valid EEA family permit issued under regulation 12 of the **EEA Regulations** or has been granted leave to enter or remain in the UK in that capacity under or outside the Immigration Rules.
 - (2) The applicant meets the eligibility requirements for an entry clearance to be granted under this Appendix in the form of an EU Settlement Scheme Travel Permit, where the entry clearance officer is satisfied that at the date of application:
 - (a) The applicant is a non-EEA citizen;
 - (b) The applicant has been granted indefinite leave to enter or remain or limited leave to enter or remain under Part 1 of Appendix EU to these Rules, which has not lapsed or been cancelled, curtailed or revoked and which is evidenced by the Home Office reference number for that grant of leave;
 - (c) The applicant:
 - (i) Has been issued with a **relevant document** by the UK under the EEA Regulations, or with a biometric residence card by virtue of having been granted leave under Part 1 of

Appendix EU to these Rules; and

- (ii) Has reported to the Home Office that that document or card has been lost or stolen; and
- (d) The applicant will be travelling to the UK within six months of the date of application.
- FP7. (1) An application made under this Appendix will be refused on grounds of suitability where any of the following apply at the date of decision:
 - (a) The applicant is subject to a **deportation order** or to a decision to make a deportation order; or
 - (b) The applicant is subject to an **exclusion order** or **exclusion decision**.
 - (2) An application made under this Appendix may be refused on grounds of suitability where any of the following apply at the date of decision:
 - (a) The applicant is subject to an **Islands deportation order**; or
 - (b) The applicant is subject to an **Islands exclusion decision**.
 - (3) An application made under this Appendix may be refused on grounds of suitability where, at the date of decision, the entry clearance officer is satisfied that it is proportionate to refuse the application where:
 - (a) In relation to the application and whether or not to the applicant's knowledge, false or misleading information, representations or documents have been submitted (including false or misleading information submitted to any person to obtain a document used in support of the application); and the information, representation or documentation is material to the decision whether or not to grant the applicant an entry clearance under this Appendix; or
 - (b)(i) The applicant:
 - (aa) Has previously been refused admission to the UK in accordance with regulation 23(1) of the EEA Regulations; or
 - (bb) Had indefinite leave to enter or remain or limited leave to enter or remain granted under Part 1 of Appendix EU to these Rules (or limited leave to enter granted by virtue of having arrived in the UK with an entry clearance that was granted under this Appendix) which was cancelled under paragraph 321B(b)(i) or 321B(b)(ii) of these Rules; and

- (ii) The refusal of the application is justified either:
 - (aa) In respect of conduct committed before the **specified date**, on grounds of public policy, public security or public health in accordance with regulation 27 of the EEA Regulations, irrespective of whether those Regulations apply to that person (except that in regulation 27 for "with a right of permanent residence under regulation 15" and "has a right of permanent residence under regulation 15" read "who has indefinite leave to enter or remain or who meets the requirements of paragraph EU11 or EU12 of Part 1 of Appendix EU to the Immigration Rules"; and for "EEA decision" read "a decision under paragraph FP7 of Appendix EU (Family Permit) to the Immigration Rules"); or
 - (bb) In respect of conduct committed after the specified date, on the ground that the decision is conducive to the public good; or
 - (cc) In respect of conduct committed before or after the **date** and time of withdrawal (if the United Kingdom withdraws from the European Union without a Withdrawal Agreement), on the ground that the decision is conducive to the public good, where:
 - (aaa) the applicant is not a family member of a **specified EEA citizen**; and
 - (bbb) the applicant's conduct committed after the date and time of withdrawal has resulted in a sentence of imprisonment.
- (4) The references in this paragraph to an order or decision to which the applicant is subject do not include an order or decision which, at the date of decision on their application under this Appendix, has been set aside or no longer has effect in respect of the applicant.
- FP8. A valid application made under this Appendix which does not meet the requirements for an entry clearance to be granted will be refused.
- FP9. Annex 1 sets out definitions which apply to this Appendix. Any provision made elsewhere in the Immigration Rules for those terms, or for other matters for which this Appendix makes provision, does not apply to an application made under this Appendix.
- FP10. Annex 2 applies to the consideration by the entry clearance officer of a valid

application made under this Appendix.

Annex 2 - Consideration of a valid application

- A2.1. A valid application made under this Appendix will be decided on the basis of:
 - (a) the information and evidence provided by the applicant, including in response to any request for further information or evidence made by the entry clearance officer; and
 - (b) any other information or evidence made available to the entry clearance officer (including from other government departments) at the date of decision.
- A2.2. (1) For the purposes of deciding whether the applicant meets the eligibility requirements for entry clearance, the entry clearance officer may:
 - (a) request that the applicant provide further information or evidence that they meet those requirements; or
 - (b) invite the applicant to be interviewed by the entry clearance officer in person, by telephone, by video-telecommunications link or over the internet.
 - (2) For the purposes of deciding whether the applicant meets the eligibility requirements for entry clearance, the entry clearance officer may:
 - (a) request that the relevant EEA citizen on whom the applicant relies as being their family member provide information or evidence about their relationship with the applicant; or
 - (b) invite the relevant EEA citizen on whom the applicant relies as being their family member to be interviewed by the entry clearance officer in person, by telephone, by video-telecommunications link or over the internet.
 - (3) If the applicant or (as the case may be) the relevant EEA citizen:
 - (a) fails within a reasonable timeframe specified in the request to provide the information or evidence requested; or
 - (b) on at least two occasions, fails to comply with an invitation to attend an interview in person or with other arrangements to be interviewed,
 - the entry clearance officer may draw any factual inferences about whether the applicant meets the eligibility requirements for entry clearance as appear appropriate in the circumstances.
 - (4) The entry clearance officer may decide, following the drawing of a factual inference under sub-paragraph (3), that the applicant does not meet the

eligibility requirements for entry clearance.

(5) The entry clearance officer must not decide that the applicant does not meet the eligibility requirements for entry clearance on the sole basis that the applicant or the relevant EEA citizen failed on at least two occasions to comply with an invitation to be interviewed.".
