#### **This introductory note does not form a part of the notice.**

The following notice gives notice of the surrender in part of an environmental permit.

This is a partial surrender to remove the temporary storage of drums on-site. This activity was listed on the permit as 'S5.6 A(1)(a) – Temporary storage of hazardous waste in a facility with a total capacity exceeding 50 tonnes', as it is listed in Schedule 1 of the Environmental Permitting Regulations. The partial surrender also removes the area of land within the existing permit boundary in which this activity was carried out by the operator.
