(Edenfield to Helmshore Road via Irwell Vale) Definitive Map Modification Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **9 September 2019**.

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at **The Business Centre, Futures Park, Bacup,** Lancashire, OL13 OBB on Tuesday 10 March 2020 at 10.00am.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement of Public Rights of Way for the area, by deleting part of Ramsbottom Footpath 130 marked H-X on the Order Map, Upgrade parts of Ramsbottom Footpaths 128, 130 and 131 to bridleway between points 1-B-C-D-F and E-D on the Order Map. Add a bridleway from Ramsbottom Footpath 131 to a point on Ramsbottom Footpath 130 shown between points F-G on the Order Map. Upgrade to bridleway part of Ramsbottom Footpath 130 shown between points G-H on the Order Map. Add a bridleway from a point on Ramsbottom Footpath 130 along Aitken Street and Milne Street to a junction with Haslingden Footpath 387 shown between points H-I on the Order Map and upgrade Haslingden Footpaths 387 and 388 to bridleway between points I-J-K on the Order Map.

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case¹ is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

4 weeks before the date of the inquiry [by 11 February 2020]

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

THE LANCASHIRE COUNTY COUNCIL (EDENFIELD TO HELMSHORE ROAD VIA IRWELL VALE) DEFINITIVE MAP MODIFICATION ORDER 2016

This Order is made by Lancashire County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act, 1981 ("the Act") because it appears to that Authority that The Definitive Map and Statement of Public Rights of Way for the County of Lancashire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i),(ii)&(iii) namely the discovery by the Surveying Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, namely a bridleway; that a highway shown in the map and statement as a highway of a particular description, namely a footpath, ought to be there described as a highway of a different description, namely a bridleway and also there is no public right of way over part of the land shown in the map and statement as a highway of a different description.

The Authority have consulted with every local authority whose area includes the land to which the Order relates. Lancashire County Council hereby order that:

- 1. For the purposes of this Order, the "relevant date" is 30 November 2016.
- 2. The Definitive Map and Statement of Public Rights of Way for the County of Lancashire shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- This Order shall take effect on the date it is confirmed and may be cited as The Lancashire County Council (Edenfield to Helmshore Road via Irwell Vale) Definitive Map Modification Order 2016.

MODIFICATION OF THE DEFINITIVE MAP

All distances are given in metres and lengths are approximate.

DESCRIPTION OF PATH OR WAY TO BE DELETED

The deletion of part of Ramsbottom Footpath 130 shown as a bold line marked H-X on the Order Map. The full width to be deleted.

DESCRIPTION OF PATH OR WAY TO BE ADDED AND UPGRADED

The upgrading to bridleway of parts of Ramsbottom Footpaths 128, 130 & 131 (shown between points 1-B-C-D-F and E-D on the Order Maps);

The addition of a bridleway from a point on Ramsbottom Footpath 131 to a point on Ramsbottom Footpath 130 (shown between points F-G on the Order Map);

The upgrading to bridleway of part of Ramsbottom Footpath 130 (shown between points G-H on Order Map);

The addition of a bridleway from a point on Ramsbottom Footpath 130 along Aitken Street and Milne Street to a junction with Haslingden Footpath 387 (shown between points H-I on Order Map);

The upgrading to bridleway of Haslingden Footpaths 387 & 388 (shown between points I-J-K on Order Map).

The width of the bridleways varies between 1.75 to 7.5 metres and the extent of the width is shown shaded on the Order Maps.

The length of bridleways is approximately 2.3 kilometres.
