

# **NOTICE OF ORDER**

## **WILDLIFE AND COUNTRYSIDE ACT 1981**

### **Section 53**

Cheshire West and Chester Council  
(Addition of particulars to the Definitive Statement for Footpath No 19, Beeston)  
Modification Order 2017

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. Following an earlier hearing, the Inspector appointed to determine the Order issued a letter in which he proposed to make modifications to the Order as drafted. Following advertisement of those proposals, objections/representations have been received.

The **start date** for the above Order is 9 January 2020.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case which contain evidence in respect of the Inspector's proposed modifications only.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by adding the following description to the statement:

A public footpath commencing at Ivy Cottage, Moss Lane (c810) at OS grid reference SJ 55467 58342 then running in a north westerly direction for approximately 78 metres to the field boundary of Ivy Cottage at OS grid reference SJ 55401 58387 then running in a westerly direction for approximately 1073 metres to Moss Lane (c810) at OS grid reference SJ 54373 58610.

The effect of the proposed modifications would be to:

- Delete the grid reference "SJ 55469 58342" for the first limitation listed in Part II of the Order Schedule and insert "SJ 55461 58343".
- Delete the first paragraph within the section headed "Width" in Part II of the Order Schedule and insert "*The width between the junction with Moss Lane at OS grid reference SJ 55467 58342 and the field boundary at OS grid reference SJ 55401 58387 is shown by red hatching on the 1910 25 inch Ordnance Survey map which is appended to this Order*".
- Attach the map outlined above to the Order.

### **Timetable for sending in statements of case and comments**

#### **Within 8 weeks of the start date [by 5 March 2020]**

The Order Making Authority, the applicant and everyone who has made an objection or representation following the proposed modifications or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after receiving it the Secretary of State will send a full copy to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to everyone who has made an objection or representation following the proposed modifications, the applicant and any other person who has previously written to us in respect of the Order.

#### **Within 14 weeks of the start date [by 16 April 2020]**

Everyone who has made an objection or representation following the proposed modifications, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the above date, the Secretary of State will send copies of the comments received to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

**All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.**
