- 1.1 The Annex to this notice sets out the pattern of written examinations to be held in the academic year commencing 1 September 2019 for Deck Officer (Fishing Vessel) Certificates of Competency.
- 1.2 The dates have been arranged following consultation with various representative organisations of the fishing industry.
- 1.3 The examinations are administered by the Scottish Qualifications Authority (**SQA**) on behalf of the Maritime and Coastguard Agency (**MCA**) and are held at their examination centres.
